

MRIA receives 11,926 with 72 aircraft movements: AASL

The top five source markets for Sri Lanka in February have been the Russian Federation, 29,084 (27%), India, 13,714 (13%), the United Kingdom, 8,575 (8%), Germany, 7,930 (7%), and France, 6,118 (6%).

Further, after 2021, MRIA facilitated the first flight of SCAT Airlines of Kazakhstan yesterday, with 188 international tourists arriving in the country. Altogether, 602 international tourists arrived in Sri Lanka yesterday, and also, Red Wings Airlines, a Russian regional leisure airline based in Moscow, carried 414 international tourists to the country while 407 tourists departed on the same flight yesterday.

AASL has made all the necessary arrangements to welcome the guests and facilitate smooth operations to process 1,009 tourist movements.

The top management of AASLappreciates the contribution of the Department of Immigration and Emigration, Sri Lanka Customs, and all other institutions at MRIA for their team effort and efficient operations in doing the needful. Major trains cancelled for the first time in history due to lack of crew

He told the media that major trains in Maho, Gal Oya, Trincomalee, and Batticaloa in the eastern zone, have been affected due to a lack of staff.

"Every essential grade in the Railways Department has been affected due to lack of staff. More than 90 locomotive drivers in rank three of the railway services have not been elevated to rank two position yet. Due to this reason, they are unable to operate locomotives," Konthasinghe said.

Meanwhile, there are protracted delays in receiving confirmations for staff who are attached to the railway on contract basis, he said.

"For the reasons stated above, the number of train cancellations have increased. Therefore, we have to cancel the train that runs between Colombo Fort and Batticoloa for the first time in the history of the railway," he said.

If this practice continues, the trains will either be delayed or cancelled. If the government does not take any action, the union will be compelled to take trade union action to protect the Railway Department, Konthasinghe added.

SL'S 6TH PERIODIC

Currently, 173 countries have ratified the ICCPR. In addition to the implementation of the Covenant, all State Parties to the Covenant have undertaken a voluntary obligation to submit periodic reports to the Committee and participate in periodic reviews.

Accordingly, Sri Lanka has submitted 5 Periodic Reports in 1983, 1990, 1994, 2003 and 2013 and has participated in 5 Reviews in 1983, 1991, 1995, 2003 and 2014.

The Human Rights Committee is a body comprised of 18 independent experts that monitor the implementation of the ICCPR. The Reviews of all countries are conducted by the Committee.

At Sri Lanka's request, the 6th Review will be conducted in hybrid format and will be led by Sri Lanka's Permanent Representative to the UN in Geneva Himalee Arunatilaka. The Sri Lanka delegation also comprises senior officials from the Presidential Secretariat, Ministry of Public Security, Attorney-General's Department, Ministry of Foreign

Affairs, and the Permanent Mission of Sri Lanka to the UN in Geneva participating in person. Senior officials from Colombo will join the Review virtually representing the Ministry of Justice, Prison Affairs and Constitutional Reforms, Ministry of Defence, Ministry of Women, Child Affairs and Social Empowerment, Ministry of Health, Department of Prisons, Department of Police, Office on Missing Persons (OMP), Office on Reparations (OR) and Office for National Unity and Reconciliation (ONUR).

"Provincial councils are being administered by the governors who are representatives of the President. The President has got control over Parliament and he is now able to dissolve it at any time. However some MPs are pleading with the President not to dissolve the House till they secure their pensions and vehicle permits. The local government bodies will soon come to be administered by special commissioners appointed by the President. Therefore circumstances would be conducive for setting up a dictatorship in this country," the MP said.

"However the day will soon come when people would tell the president to 'shut up' and silence him," he added.

Also, the MP said the Election Commission should hold local government election in line with the recent ruling given by the Supreme Court.



Price of bread should reduce to Rs.100: **Bakery Owners**

Due to the need to maintain the bakery industry, bakery owners have to bear the burden of various problems affecting the bakery industry

He said that the support of the government is expected for this and that the bakery industry, which is currently stalled, can be restored only if the prices of bakery products including bread buns are reduced.

A loaf of bread is currently being sold for Rs.150, Rs.160, Rs.170 and in some areas for Rs. 180. He said that the consumer cannot afford those prices which is why the sale of bread buns has decreased by 20 to 25 percent.

Due to the increase in electricity bills, the bakery industry has been heavily impacted, which has led to the collapse of the industry.

Due to the need to maintain the bakery industry, the bakery owners have to bear the burden and due to various problems affecting the bakery industry, 5,000 out of 7,000 bakeries are closed, Jayawardena said.



FIRE RIPS THROUGH

uthorities in Bangladesh have opened an investigation into the circumstances which led to an inferno at a Rohingya refugee camp on Sunday that destroyed around 2,000 shelters and left thousands of people homeless.

Local media has reported that one man – who is understood to be a refugee – has been detained in connection with the fire. Police are trying to determine whether or not the blaze was started "as an act of sabotage," according to Mohammad Mizanur Rahman, the chairman of Bangladesh's Refugee Relief Repatriation Commissioner.

Some 2,000 shelters have been burnt, leaving about 12,000 forcibly displaced Myanmar nationals shelterless," Rahman told the AFP. It is not yet clear how the fire, which occurred at 2:45pm local time on Sunday, began but it is thought to have spread quickly through tarpaulin shelters and by gas cylinders in kitchens. No casualties have yet been reported in the fire, which was brought under control after three hours.

The refugee camp in the country's southeast is considered to be the largest of its kind. The United Nations High Commissioner for Refugees (UNHCR) tweeted on Sunday that 90 facilities, including hospitals and learning centers, had been destroyed in the fire. Around 35 mosques were also reported to have been damaged or destroyed.

Bangladesh authorities are working with domestic and international aid groups to supply food and temporary shelter to those affected by the blaze.

Girls' poisoning 'unforgivable': Iran's Khamenei



ran's Supreme Leader Ayatollah Ali Khamenei

Iran's supreme leader said Monday that if a series of suspected poisonings at girls' schools are proven to be deliberate the culprits should be sentenced to death for committing an "unforgivable crime."

It was the first time Supreme Leader Ayatollah Ali Khamenei, who has the final say on all matters of state, has spoken publicly about the suspected poisonings, which began late last year and have sickened hundreds of children.

Iranian officials only acknowledged them in recent weeks and have provided no details on who may be behind the attacks or what chemicals — if any — have been used.

Unlike neighboring Afghanistan, Iran has no history of religious extremists targeting women's education.

"If the poisoning of students is proven, those behind this crime should be sentenced to capital punishment and there will be no amnesty for them," Khamenei said, according to the state-run IRNA news agency.

OUR THOUGHT

DUMP POLITICIANS' RUBBISH, EVALUATE THEIR POLICIES

n spite of the Supreme Court having issued an interim order preventing the Treasury Secretary from withholding funds for the local government elections from the allocations made for the purpose by the budget that was passed in December last year, the uncertainty in holding election still prevails. The Election Commission had told the Daily Mirror on Sunday that elections could be held only in the latter half of April and this might provide the government ample opportunity to create new issues delaying the elections.

However, political parties would continue their campaigns unless the events in the days to come did not put off the polls months behind. Yet, what is worrying is the propaganda programmes already launched by parties are fast turning into smear campaigns instead of being awareness programmes. The last year's Aragalaya stressed the need of a system change and not a mere change of heads in the name of regime change. A system change would be a remote possibility unless the voters are better informed of the plans and programmes of political parties for taking the country out of the mess that it is currently in.

The two parties in the government, the Sri Lanka Podujana Peramuna (SLPP) and the United National Party (UNP) seem to be unfazed by the election either in some sort of certainty in the postponement of the elections or due to the apprehensiveness about the emerging political trends in the country against them. Against this backdrop the recent opinion polls justify the marathon campaigns by the Samagi Jana Balawegaya (SJB) and the Jathika Jana Balawegaya (JJB).


Nevertheless, all hopefuls and those hopeless have resorted to mudslinging against other parties. They are primarily spending time and energy to explain the people as to why they shouldn't vote for others rather than why they should vote for themselves. They refresh the older generation's memory about ruthlessness of others when armed clashes broke out between the armed forces and the rebels in the past. They recall how others behaved as political rogues or teamed up with such evil groups in the past. They accuse others of stealing or destroying public properties.


In fact, no political party in the country can absolve itself from these sins. Some of the past and present leaders of almost all parties have blood stains in their hands. The ruthlessness of the JVP during its two insurrections is well known, despite the governments of the day having pushed them to take to arms. It was during the government led by the leaders of the Sri Lanka Freedom Party, Lanka Samasamaja Party and the Communist Party of Sri Lanka in 1971 that Sri Lankans saw the tyre-pyres and bodies floating in rivers, for the first time after the Matale Rebellion in 1848.

The number of unlawful killings and disappearances at the hands of armed force and state sponsored death squads during the 1988/89 JVP insurrection was said to be over 60,000. Neither the UNP nor the SJB can wash their hands of those crimes. The names of torture chambers that were said to be operating those dark days are also circulating in social media these days. Thousands of civilian casualties in the northern and eastern battlefronts as well as extrajudicial killings took place in places like the Welikada Prison during the Mahinda Rajapaksa regime are still haunting the country, every year when the UNHRC meets in Geneva. Yet, now pots are calling the kettles black.

The fact that the current economic mess is the outcome of the 75 year-long mismanagement and large scale corruption has gone international and been accepted even by those who ruled the country. Unfortunately, the same politicians and groups that helped them are still in the field and people have to choose the future leaders from among them again. The people might have some hope, only if any of these individuals and groups have reformed, despite their dark history. Hence, it is up to the politicians to indicate that they have reformed.

Though the election that has been declared would not immediately change the regime, it has gained much significance since it is in a way the first opinion poll after the Aragalaya that immensely changed the political thinking pattern of vast number of people in the country. Definitely, this election is going to be a trend setter. Therefore, Politicians must come out with their policies and programmes to resolve the issues faced by the people and the people in turn must not be misled by the smear campaigns and rhetoric by politicians to commit the same mistake they did for over seven decades. Instead, they must critically and objectively evaluate the policies and programmes of political parties and their viability, before entering the polling booth.

INFLATION, INTEREST RATES AND ECONOMIC DEPRESSION



nflation seems to be the only major concern for the economic policymakers shaping Sri Lanka. They include the Central Bank, the Finance Ministry, and the IMF. An economic depression is underway in the country with tremendous disruption of livelihoods, mass unemployment, and collapsing businesses. The GDP contracted by a tenth last year and it is likely to contract in similar proportions this year. But all this is of secondary concern to the economic establishment.

Austerity policies and the Central Bank policy rate, which was increased from 6 percent to 15.5% a year ago to satisfy the IMF recommendations, have strangled the economy. Given that the economy is grinding to a halt, the worst thing to do is what the Central Bank has done with its announcement of another interest rate hike of 100 basis points, increasing the policy rate on March 3, 2023 to 16.5%.

The policymakers' push for economic contraction, which they justify in terms of satisfying the IMF, and the IMF's rationale, which it articulates as fighting inflation, are democratically unaccountable, economically flawed and merely meant to serve the long-term interests of global capital. The suffering of our people, who are being pushed to starvation, is merely reduced to collateral damage by our comprador elite and their masters. The IMF is the voice of the latter, and the guardian of global capitalist interests.

CENTRAL BANK'S POSITION

The Central Bank of Sri Lanka is no longer independent. It constitutes a clear and present danger to the country as an agent of the IMF. This is what the Monetary Board of the Central Bank had to say in its statement on March 3, 2023:

"Given the necessity of fulfilling all the 'prior actions' in order to move forward with the finalisation of the IMF Extended Fund Facility (EFF) arrangement, the Monetary Board and the IMF staff reached consensus to raise the policy interest rates, in a smaller magnitude, compared to the adjustment, which was envisaged during the initial stage of negotiations.

This decision demonstrates Sri Lanka's commitment to the IMF-EFF arrangement, which has been pursued by the Government in order to ensure stability in the economy on multiple fronts. The finalisation of the IMF-EFF arrangement is expected to benefit all stakeholders and bolster confidence, which would help restore stability in the economy on a sustained basis. This will incentivise more foreign exchange flows in the period ahead that would aid the economy to overcome the prevailing economic crisis. The Board was of the view that the economy has already traversed through the most difficult and unprecedented times with tremendous resilience and strongly believes that today's

decision would pave way for a fasterthan-expected deceleration of inflation." I quote this statement at length because

it illustrates the inability of Sri Lanka's policymakers to think in the interest of the country, and how they blindly cow down to the demands of the IMF. More importantly it is evident of the lie about controlling inflation that is told to the public, even though it is about serving the class interests global capital. Indeed, while the statement above talks about higher interest rates to "incentivise more foreign exchange flows in the period ahead", in reality, it is merely about remaining in the good books of global finance capital. Following Sri Lanka's premature default, which I have explained in recent writings, there is little chance of market oriented global financial flows into the country anytime soon.

The high levels of core inflation in Sri Lanka reaching 60% and food inflation reaching 90% over the last year was caused by a one-time change in price levels due to the sudden devaluation of the rupee from Rs. 200 to Rs. 360 per US\$. Thus, the price of all imports into Sri Lanka rose by 80% over night, even as the Government did little to subsidise even essential goods. In fact, in tune with the IMF recommendations, at that very crucial moment of price hikes, the Government cut any subsidies that existed. For example, market pricing of fuel has led to a three- to four-fold increase in the price of petrol and kerosene. Sri Lanka now consumes about half the amount of fuel compared to a year ago, which is contributing to the tremendous contraction and economic depression. In addition, in the months after the start of the war in Ukraine a year ago, there were price increases in global commodity markets, which worsened inflation levels all around the world. The passing on of such price increases also contributed to the extremely high inflation levels in Sri Lanka.

Inflation, however, is calculated yearon-year. Therefore, given that price hikes, dubbed as inflation, took place mainly between March and September last year, inflation levels in Sri Lanka are likely to decline steadily starting March this year. If there are no further shocks, it may well reach very low levels after September this year. The Central Bank dishonestly claims that it is its policies that are reducing inflation, when the logic of the calculation of inflation year-on-year should be apparent to the Central Bank's policy makers and any economist with a bit of brains. Furthermore, even if inflation comes down to single digits later this year, it means nothing to the working people because there has been a one-time tremendous increase in the cost of living without a corresponding increase in nominal wages. Hence in the absence of any wage increases in the near future, the state of tremendous wage repression will continue with the fall in real wages by as much as 40% due to the cost-of-living increase. In other words, real wages will remain at that low level, even if official year-on-year inflation levels come down to zero later this year.

GLOBAL CAPITAL INTERESTS

What these extremely high interest rates in fact do is slow down the economy. Small producers and businesses are unable to borrow working capital, as commercial banks pass on the interest rate hike. Loans for production are now near 30%. Accordingly, many small producers and businesses are either stopping production or going bankrupt, devastating livelihoods and throwing people out of jobs. Such dispossession in turn reduces the bargaining power of labour, so that tremendous wage repression can be maintained.

The recent protests by the professionals against the Government for the income tax increases for those earning more than Rs. 100,000 per month, has now discovered a reality check as IMF officials have gone on record defending such taxes. Now, Rs. 100,000 per month for a family of four amounts to about US\$ 2.30 per person per day, a level just above the World Bank's line of extreme poverty set at US\$ 2.15 per person per day. Furthermore, the rise in interest rates has meant that personal loans that professionals had taken to build a house or buy a vehicle few years ago, now require much higher monthly payments. For example, ten-year loans of say Rs. 5 million or Rs. 10 million will require additional monthly loan payments of Rs. 20,000 or Rs. 50,000 per month respectively, reducing these households' disposable incomes by that much, even as cost of living has increased by 60%. The professionals are rightly up in arms against the Government, but they are yet to realise that those dictating the terms of their misery is the IMF.

This policy of high interest rates to curb so-called inflation is not only being applied in Sri Lanka. Since the neoliberal turn, and rise of the class project of finance capital, inflation is seen as the enemy to be defeated by global capitalist interests. The long economic downturn of the 1970s was solved in the interest of capital by the massive interest rate hikes introduced by Paul Volker of the Federal Reserve of the United States, earning the name the "Volker Shock', which initiated an era of much higher returns for finance capital. Furthermore, when there are higher levels of wage inflation which is not the case now – even if it can be sustained in line with economic growth, it is opposed by the hegemonic policy makers because the returns to capital decrease. This orthodox doctrine of maintaining low inflation with high interest rates has become so entrenched that economists who curry favour with the establishment dare not challenge it.

The world has been reconfigured to serve global finance capital over the last four decades. The global crisis underway is a fight over the question, who pays for the crisis? Will it be capital or labour? And in this great battle for the future of the global political economic order, the suffering and even starvation of the Sri Lankan people is of little concern for the IMF and for that matter the great powers that control it. If the citizenry of this country doesn't realise these dangers amidst the economic depression, and if we continue to accede to the dictates of the IMF, we are only digging our own graves.

REMEMBERING A RENOWNED CHIEF CONSULTANT JMO

Alwis, or Dr. L.B.L. de Alwis, retired Chief Consultant Judicial Medical Officer Colombo, went to be with the Lord, after a very brief illness. As inconspicuously as he sauntered into the workplace, the prestigious Office of the Colombo Judicial Medical officer, he left us silently leaving a void that cannot be filled.

All academic staff at the Jniversity Departments of Forensic Medicine, Professors, senior lecturers, lecturers alike as well as Judicial medical officers in the Health Ministry remember him with love and fondness. He was an honest person with integrity who made no compromise when it came to oublic service.

Dr. de Alwis graduated from the Colombo Medical College in 1972 and served in Talampitiya in

the Kurunegala district and at Homagama before being appointed the Judicial Medical Officer at the then Ragama General Hospital in 1975.

Appointed to the Judicial Medical Office n Colombo in 1980, he was subsequently appointed Chief Consultant Judicial Medical Officer in 1992 and retired in 2007. He was the longest serving Chief Consultant Judicial Medical Officer in Sri Lanka.

Dr. de Alwis rendered an invaluable service to the development of Forensic Medicine and Forensic Pathology as a specialty in the country; being instrumental in founding the College of Forensic Pathologists of Sri Lanka

in 2000 and serving as its founder President. Due to the recognition he had gained, all controversial suspected murder cases from all parts of the country were referred to him. He would look hard and long, silently, at a cadaver, when we grappled with a mysterious death, and point towards a place and say, "Dissect this area". Lo and behold there

r. Lucian Bernard Lalantha de we found the seat of violence. Such was but also in the other professions he came his high intelligence, insight, instinct and invaluable experience.

Dr. de Alwis was one of the humblest of doctors. One senior Board certified Specialist in Forensic Medicine of the PGIM Colombo, now working in the UnitedKingdom wrote sometime back, "the greatest teacher that I respect in my whole life is Dr. L.B.L.de

Alwis who retired after rendering an excellent service to the country. Although I used to address him as "sir" by habit, he associated with us as a friend though with great respect"

He used public transport until the last days of his service, walking leisurely to the Railway station in humble attitude, not utilizing even the official vehicle provided for him. Wealth, fame and glory were never his objective, in all the ventures he undertook, but fame and glory followed him throughout his career.

As a Visiting lecturer and External Examiner in Forensic Medicine his services were utilissed by the Universities of Colombo, Peradeniya, Ruhuna, Jaffna, Kelaniya and Sri Jayewardenepura and the Sri Lanka Medical Council which

appointed him as Co-ordinator and Chief

Examiner in Forensic Medicine for the

ERPM examination for foreign graduates.

During his tenure as Chairman, Board of Study in Forensic Medicine and Chief Examiner in Forensic Medicine of the Postgraduate Institute of Medicine, University of Colombo for 6 years, his hard work produced many Specialists in the field. The comprehensive Forensic Medicine books on Forensic Medicine and Toxicology written by him were sold at only the printing cost, true to his nature as he had no intention of making such profits.

Dr. L. B. L. De Alwis was greatly respected not only by those in his own profession, into contact with. Senior Legal luminaries branded him as the most excellent expert medical witness in the country, surpassed by none who followed him. In our eyes too Dr. Alwis, as he is fondly called, was an inimitable expert medical witness, who would express his opinion in criminal cases, without mincing his words, irrespective of the parties involved.

Many a court witness feigning illness would be brought to him for examination, to determine their fitness to attend courts. A number of such powerful men were certified as fit to appear in courts by him, in spite of their bringing 'dubious' medical certificates from doctors of high repute. He brought professionalism, integrity, honesty as well as compassion and humility to the profession of forensic medicine. It is with great respect that we bow to Dr. L.B.L. de Alwis, who left us a legacy. To follow his footsteps of competence, professionalism, integrity and humility is the best salute we could give this great man.







Windforce's Mannar project's cost increases further as crane topples

Windforce PLC has flagged further cost ncreases in the two wind power plants it is setting up in Mannar.

In May, last year, the company informed the Colombo Stock Exchange (CSE) that the total project cost of the 10MW+5MW wind power plants would amount to Rs.6.65 billion, due to the rupee devaluation and cost increase in local material and services.

Last week, the company informed to the CSE that the cost would go up further to Rs.7.45 billion, due to a toppling of a crane on the project site.

"The company wishes to inform that during the erection of the wind turbine bottom tower at location 03, Nanattan, Mannar project construction site, the hired 500T main crane toppled. This crane is unrepairable and the company had planned to import another 750T crane on rental to continue the project. On a more positive light, no casualties were reported in the accident, due to the safety precautions in place," a stock market filing by Windfore said.

"The damage was recorded at Rs.995 million, out of which approximately Rs.377

million will be covered by the project from 75:25 to 65:34. The additional IPO insurance, excluding the finance cost and other incidental cost relating to the accident. In addition, there is also a Rs.179 million cost escalation, due to the increase of VAT and global raw material prices. Hence, the estimated cost of the project has increased from Rs.6,653,000,000 to Rs.7,450,000,000,"

"Consequently, the equity infusion for the project from the company's IPO funds is to be increased to Rs.2,500,000,000, with an expected change in the debt equity ratio

funds will be sourced by reallocating the funds for the Tororo Phase II Project, which is delayed, due to the on-going grid study by the Electricity Regulatory Authority (ERA) in Uganda. This project will commence upon the completion of the grid study in July 2023 and it will be funded by the remaining IPO funds, company's own reserves and debt financing," it further said.

However, Windfore said as the Power Purchase Agreement (PPA) is yet to be signed, an 80 percent upward tariff rate revision is

expected to the US dollar at the indicative LKR/USD rate published by the Central Bank, seven working days prior to the signing of the

"As a result of the tariff revision, the project will likely earn an equity IRR of 75 percent, with a project IRR of 9.2 percent, at 1,5.6 percent WACC. Moreover, negotiations are underway to further increase the tariff to compensate the prevailing high interest rates in the market, which will likely increase the equity IRR to 15.3 percent, with a Project IRR of 73.2 percent," the filing said.

China approves US\$1.3bn loan rollover for **Pakistan**

REDIESS Industrial and Commercial Bank of China Ltd on Friday approved a rollover of a US \$ 1.3 billion loan for cash-strapped Pakistan, which will help shore up its depleting foreign exchange reserves, Finance Minister Ishaq Dar said.

The facility will be disbursed in three instalments. The first one of US \$ 500 million has been received by Pakistan's central bank, Dar said in a tweet.

'It will increase forex reserves," he said. The money, which Dar said has been repaid by Pakistan to the ICBC in recent months, is crucial for the South Asian economy, which is facing a balance of payment crisis, with its central bank foreign exchange reserves dropping to levels barely able to cover three weeks of imports.

Faster decline in inflation likely due to rupee appreciation

- CB projects inflation to return to desired 4-6% range by December
- However, IMF's approach towards inflation remains cautious

he Central Bank last Friday projected a faster decline in the rate of inflation in the coming months, as businesses and households will benefit from the relative strength in the rupee in recent times, which gets translated into lower imported goods prices.

However, Central Bank Governor Dr. Nandalal Weerasinghe said some commodity prices such as energy could fall faster than the rest, as their prices are determined based on automatic pricing formula pinned to the global commodities prices.

The other prices in the economy could come down faster than the authorities previously anticipated in their inflation projections, in the absence of any exogenous factors.

The Central Bank and International Monetary Fund (IMF) had conflicting views on the future inflation path, which resulted in a 100-basis-point surprise policy rate hike last week.

While the Central Bank's projections show a faster decline in inflation towards its desired range of the 4 to 6 percent band by the year's end, the IMF appears to be taking a more cautious view and is feeling uneasy about the extremely high inflation prevailing

However, Dr. Weerasinghe, who clearly showed displeasure towards the policy decision that had to announce on Friday, said people can judge whose projections were more accurate by the end of the year.

The monetary policy typically has

long and variable lags and hence, overdoing monetary tightening could break the economy, sometimes taking a lot more effort and time to Some analysts, including First

Capital Research, have been calling for policy easing before the economy reaches an irrecoverable breaking point. Sri Lanka tightened its monetary

policy by a record 950 basis points in 2022, which helped the country to break the inflation spiral as early as September.

Ŝri Lanka's Colombo inflation further cooled down to 51.7 percent in February from a year earlier levels, declining for the fifth consecutive month.

Dollars stashed finding their way back to market—CB

The Central Bank said it was overserving a trend where large amounts of foreign currency, which had been stashed away, now being released, further increasing the supply of dollars to the market and thereby strengthening the rupee.

Despite many attempts in the last two years, some exporters and others, who were earning in dollars and other foreign currency, stashed away a substantial amount of dollars, expecting further devaluation of the rupee.

However, last week's rupee appreciation of around 5 percent against the US dollar prompted them to sell the foreign currency they stockpiled into the banking sector, boosting the foreign currency liquidity further in the domestic market.

The continued appreciation seen in the

rupee against the US dollar last week took many by surprise but the Central Bank said if it didn't intervene, the rupee would have crashed even further.

The Central Bank bought US \$ 308 million from the market in the five days last week, the most it bought in any five-day stretch to prevent sharp volatility in the exchange rate.

Central Bank announces fresh round of relief for borrowers

The Central Bank has medium-sized enterprises. issued two circulars, one to banks and another to finance companies, to support businesses and the individuals who fell into fresh difficulties, due to the ongoing economic crisis, which sent interest rates through the roof.

The final round of moratoria expired on January 7, this year and since then, there has been an uptick in the nonperforming loans in the

Hence, this new round of the relief will be offered on a case-by-case basis, after an objective assessment of the repayment capacity of

each borrower. When extending relief however, the Central Bank requested the banks to give priority to the small and

fixed-income earners and pensioners, who are badly affected by the present macroeconomic conditions.

The Central Bank also requested the banks to restructure and reschedule both performing and nonperforming facilities, in view of the ongoing crisis, on a case-by-case basis. Meanwhile, the Central Bank further requested the banks to suspend any recovery actions against credit facilities, which fell into non-performing status on or after January 01, 2020, also on a caseby-case basis, subject to objective assessment on the future repayment capacity and viability of the business, upon the condition that the borrower

submits an acceptable

repayment plan.

The banks were also requested to facilitate early settlement of facilities, if a borrower chooses to do so, without charging an additional fee such as early settlement charges and future interest recovery on

lease facilities. Until recently, the Central Bank maintained that it may no longer grant any more relief, after the final round of debt relief came to an end early January, this year.

However, it drew flak from several quarters, due to the need for further support for the small and medium-sized businesses struggling to recover from the fallout of the pandemic and then the economic

High-grade mineral sands project ready to commence development in Eastern province

Capital Metals PLC, a UK mineral resources company listed on the London Stock Exchange, is ready to commence development of its highgrade mineral sands project in Sri Lanka's Eastern province.

The extensive studies completed by the local Sri Lankan subsidiary Damsila Exports (Pvt.) Ltd indicated the availability of commercial quantities of high-grade mineral sands in this region. Local investment company Keynes Investments (Pvt.) Ltd was recently brought in to hold 60 percent of Damsila.

Keynes is principally held by Dinal Peiris, who is also Chairman of Lanka Aluminium Industries PLC Group and several other well-known companies in Sri Lanka.

The project commenced in 2015 with Capital Metals, a specialised mineral resource exploration and development company with significant international experience, acquiring ownership of Damsila, which held the initial exploration licences.

With investment from Capital Metals, Damsila completed numerous studies and obtained the approval from the Coast Conservation and Coastal Resources Management Department





for its environmental impact studies, following extensive local community and governmental consultation. With total expenditure to date of over US \$ 11 million, Damsila is now awaiting the final approval to commence development.

'We are delighted to partner with Capital Metals in this environmentally responsible mining project. This is a first of its kind in Sri Lanka with modern mining practices to protect the environment and bring the muchneeded employment and training to the local

community," said Peiris. "With a development plan to ensure a win-win outcome from this project by adhering to rigorous standards for mining and rehabilitation principles, we will leave the area in a better state than we found it. The key advantages of the planned operations are that no blasting or chemicals are required and there will be continuous cleaning and restoration of the mined areas to remove the black mineral sands, leaving the golden sands in place. This project will also help to position Sri Lanka as a strategic and responsible source for these critical minerals in the global marketplace," said Capital Metals CEO and Director Michael Frayne.

The project requires a total investment of over US \$ 80 million and will bring a multitude of benefits to Sri Lanka and its people, as it will generate the much-needed foreign exchange from export income, significantly upgraded infrastructure, employment and skill transfer as well as various programmes to support local communities. It is estimated that over 300 new direct jobs will be created and the Sri Lankan government will receive over US \$ 100 million in royalties and taxes.

Faster decline ...

Meanwhile, the so-called core inflation, barring oftenvolatile food, energy and transport, declined to 43.6 percent, from 45.6 percent through January.

Sri Lankan economy has turned a corner faster than many would have expected and political and social stability are sine-qua-non for the full recovery, which could be expected from as early as end of this year.

Dollars stashed ...

It said excessive volatility on either side isn't good for the market and hence, will not shy away to intervene going forward, although it allowed greater flexibility in the exchange rate from today onwards by removing the forex trading band.

Meanwhile, the Central Bank also said that despite the relaxation of the import controls, it hasn't seen a significant pick up in the imports.

It estimated an import bill of US \$ 1.38 billion for last month, which is only 73 percent of the country's peak-level imports. The Finance Ministry has removed most of the

remaining controls on imports, which were imposed last

Commenting on the foreign exchange debt repayments earmarked for the first half of this year, which was estimated at US \$ 2.5 billion and received the Cabinet nod a week ago, the Central Bank said it was a misunderstanding on the part of the Cabinet, which hadn't

taken the debt restructuring into consideration. Central Bank Governor Dr. Nandalal Weeraisnghe said the debt obligations would become true obligation, only

after the debt restructuring was finalised. However, he said the US \$ 200 million swap facility with Bangladesh Bank would be settled in September.

Toblerone to drop ...

history and will continue to be so for the future". In 2016, Toblerone courted controversy by changing the design of the chocolate bar to space out the distinctive triangular chunks in a bid to keep down costs.

After much criticism, the company reverted to the original shape two years later.

Singapore Court ...

Anglo-Swiss multinational commodity trading and mining firm based in Baar, Switzerland and insured under an open policy with Lloyd's of London. The four witnesses were all present or former employees of SGS Testing and Control Services of Singapore (SGS Singapore). SGS Singapore, which runs the Singapore Laboratory of Geneva-based global inspection giant SGS, was appointed by LIOC to report on the quality of the cargoes before the shipment from Singapore aboard Vinalines Glory and had confirmed that they were on spec in all respects prior to loading. The dispute arose when the Vinalines Glory arrived in Colombo on February 8, 2013 and the cargoes were sampled and tested by the laboratories at Ceylon Petroleum Storage Terminals Limited (CPSTL) and the Ceylon Petroleum Corporation Refinery.

The CPSTL lab reported that the samples of diesel and marine diesel taken from the vessel in Colombo failed to meet the required specifications in appearance and colour. SGS Singapore came under the microscope in the CHC when LIOC asked the global inspection firm to give evidence about the quality tests carried out in Singapore prior to the cargo being loaded. SGS Singapore said that it needed Glencore's permission to testify in the CHC and declined to provide LIOC with the evidence sought, on alleged grounds of confidentiality owed by SGS Singapore to Glencore.

Being based outside the jurisdiction of the CHC, SGS Singapore could not be compelled to appear before it and give the evidence required by LIOC. LIOC then made an application to the CHC to make a Request for Judicial Assistance from the Singapore courts to compel the global inspection firm to give the required evidence before the Singapore HC and have that evidence transmitted to Colombo. The ship owners opposed LIOC's application. High Court Judge M. Ahsan R. Marikar, as he then was, rejected the ship owner's objections and ordered the Justice Ministry in Sri Lanka to issue a Request for Judicial Assistance to the Supreme Court of Singapore. The Covid-19 pandemic delayed matters but on the application of LIOC's Singapore lawyers Drew & Napier, the Singapore HC permitted LIOC to summon the required witnesses to give evidence before it with regard to the quality tests carried out by SGS Singapore. The examination of witnesses concluded on October 7, 2022 and the Singapore High Court ordered SGS Singapore to pay SGD 20,000.00 to LIOC for its costs. The evidence obtained by the High Court of Singapore and transmitted to Sri Lanka is now admissible as evidence in the Colombo High Court.

The Sri Lanka Ministry of Education has been conducting ICT training for teachers ever since I arrived in this country 20 years ago. Many schools have also been provided with computer labs. However, to achieve gender

equity in digital literacy one needs to think from a gender transformative perspective. Computer labs should not only be used to teach computer science if the data shows a lack of gender equity in uptake of the subject. Across the world,

this approach has resulted in a gender gap in entry-level tech employment. However, the international NGO, 'Girls who Code' claim to be on track to closing this gap with their beneficiaries through providing fun coding activities that girls find meaningful. Our schools should look to doing the same.

The one mistake that the SL Ministry of Education has made is in thinking that the Internet is the key to online learning. Yes, students in rural areas or from poorer families were disadvantaged during the pandemic because of an inability to access online learning materials. But those materials could have been made available offline. An example of this in operation is the Cambodian government's Tabs on Wheels project where students access eLearning materials stored on an offline content server using a class set of tablet computers stored for safety in a mobile charging cart. Many great learning apps work offline and are available in local languages (e.g. Google Read Along and the PhET STEM simulations). The ToW project also solves the common problem of a lack of device ownership. It also temporarily solves the common problem of parents being reluctant to allow their daughters to go online because of the risk although, ultimately, to be digitally empowered, girls do need to go

online. Google's 'Be Internet Awesome' programme teaches young people the fundamentals of digital citizenship and safety so they can explore the online world with confidence. Learning with technology is the key to empowerment. After all, for every challenge we face, "There's an App for That".`
