- (4) Licensed permanent buildings and temporary buildings erected with my approval at Sella Kataragama;
- (5) Permanent and temporary buildings along Buttala road north of its junction with Nagahaveediya;
- (6) Permanent buildings facing and along Kirivehera road up to the Circuit Bungalow fenced premises from Kirivehera Maluwa.

For the purposes of this notice every building where road frontage is less than 50 feet from the centre of the road shall be deemed to be a building along the road.

No food or drink of any sort shall be sold or distributed at any other place within the CAMP AREA at Kataragama and Sella Kataragama.

Any one contravening these regulations will be liable to prosecution.

KATARAGAMA ESALA FESTIVAL—1970

THE attention of the general public is drawn to the Regulations governing pilgrimages to Kataragama and Sella Kataragama, appearing in *Ceylon Government Gazette* No. 9,859 of April 30, 1948, No. 10,000 of July 22, 1949, No. 11,225 of February 7, 1958, No. 12,508 of 7th July, 1961, and No. 12,947 of 2nd March, 1962.

In connection therewith it is notified that—

- (a) No temporary buildings shall be put up in the Camp Area at Kataragama and Sella Kataragama, without a permit from the Authorised Officer;
- (b) No permits for boutiques in temporary buildings will be allowed in sacred area at Kataragama, viz.:—
 - (1) The Mahaveediya.
 - (2) Pitaveediya.
 - (3) That portion of Buttala road between Pitaveediya and Mahaveediya.
 - (4) The roads connecting Mahaveediya and Pitaveediya.
 - (5) The area abutting on the Maha Devale, the Theivani Amman Kovil and Valli Amma Devale;
- (c) No barber saloon will be allowed anywhere in the Camp Area at Kataragama, within 100 yards of the river except below the concrete bridge;
- (d) No one will be allowed to bathe or take water from the river below the cattle bathing section at Kataragama. To prevent possible outbreak of diseases, people should use those areas of the river which are specially preserved for drinking, bathing and for watering and bathing cattle and respectively;
- (e) No vehicle including bicycles and carts will be allowed in the Camp Area without a permit from the Authorised Officer.
- (f) No temporary building should be put up within 50 yards of the river bank at Sella Kataragama;
- (g) No person shall beg or solicit alms within the Camp Area except within the road from Kirivehera to Sella Kataragama, commencing at a point $\frac{1}{4}$ mile from Kirivehera and ending at a point $\frac{1}{4}$ mile from Sella Kataragama shrine on this road;

(h) No alms whether in the form of money or otherwise shall be given or distributed to beggars within the Camp Area except within the area appointed *vide* (g) above.

Any one contravening these regulations will be liable to be prosecuted.
