The Commissioner of Labour by his Order dated 28.9.69, by virtue of the powers vested in him under section 3 (1) (d) of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon (1956 Revised Edition), as amended by Industrial Disputes (Amendment) Acts Nos. 14 and 62 of 1957, 4 of 1962 and 39 of 1968 (read with Industrial Disputes (Special Provisions) Act No. 37 of 1968) referred the abovementioned dispute to me for settlement by arbitration.

The dispute, as set out in the Statement of the Commissioner of Labour, appended to his Order, is "whether G. V. de Silva (Watcher), is entitled to receive wages and/or any fringe benefits for the period during which he was under interdiction (i.e., 2.2.66 to 1.12.67)".

Mr. N. L. Perera of the Ceylon General Workers' Union appeard for the Union and Mesrs. S. R. de Silva and K. Nagalingam, Assistant Secretaries, Employers' Federation of Ceylon, successively appeared for the Employer-Company.

The facts of the case appear to be as follows: Mr. G. V. de Silva was employed by Messrs. Brown & Company (Brown's Group) as a temporary watcher in 1965. Towards the end of 1966 the Stores of Messrs. Dunlop Limited situated within the premises of Messrs. Walker & Greig (Brown's Group) were broken into and robbed. Police investigated and charged certain persons, including De Silva the area watcher. The Union stated, which was not denied by the Company, that De Silva was at first not implicated but was required by the Police as a witness. This he refused whereupon he was arranged with complicity in the theft. The Police had then informed the Company of his prosecution for necessary action by his Employer. In the circumstances the Company had no alternative but to suspend him from his duties till the results of the case became known. In February, 1967, the Magistrate discharged De Silva but directed that a fresh plaint be filed against him. From this second case De Silva was discharged in December, 1967. The Management promptly took him back and also paid him, ex-gratia, a sum of Rs. 500 in cosideration of his non-employment during the period 2.2.66 to 30.11.67 (22 months).

At the time De Silva was suspended from work he was still

At the time De Silva was suspended from work he was still on a temporary (daily-pay) basis according to which his services were terminable at 24 hours notice on either side. The Company, however, did not actually discontinue him, apparently because they themselves had brought no charge or held no inquiry against him, but was mearly forced to take this measure due to the Police action, pending results of the Court case.

De Silva has lost 22 months' pay as a result of his being implicated in the theft case, but it appears it would not be fair to lay the full liability for this on the Employer, who also had to employ a substitute in his place for the period. The circumstances of this case clearly indicated that an equitable compromise was necessary.

On the 30th June, 1970, parties informed me that the dispute is settled and that they have agreed on the payment by the Company to De Silva of a sum of Rs. 1,250, which does not include the sum of Rs. 500 already paid to him ex-gratia. I consider this settlement reasonable and equitable and make Award accordingly.

The sum of Rs. 1,250 was handed over to G. V. de Silva by the Company's representative, Mr. K. Mackwood in the presence of Mr. N. L. Perera the Union representative in open Court today, and the parties have signed the record in full recentage. acceptance.

Leaflet on First Aid

Scratches and slight wounds

Treat every scratch and slight wound immediately. The longer the delay, the greater the risk of infection.

Remove any foreign bodies which are visible and can be picked out or wiped off with a piece of clean dressing.

Do not wash the wound. Clean the surrounding parts if necessary with soap or other suitable solvent.

Apply flavine to the broken surface.

Apply a sterilized dressing of suitable size to the wound.

Additional packing with cotton wool held in place by adhesive plaster or bandage can be applied over this dressing if necessary.

Wound accompanied by bleeding

Elevate the bleeding part except if a fracture of a bone is suspected.

Expose the wound removing as little clothing as necessary to do so.

Remove any foreign bodies which are visible and can be easily wiped off with a piece of clean dressing.

Do not dislodge any blood clot that may have formed. Clean the skin around the wound.

Apply a sterilized dressing of suitable size.

Maintain pressure on the area of the wound by placing cotton wool or the dressing and pressing firmly while applying adhesive plaster or bandage.

Septic Infection of a wound is caused by introducing germs into it. A sterilized dressing should therefore always be used. Ordinary medicated lint does not remain sterile after handling. Hands are never free of germs, and should never touch the wound or the part of the dressing to be applied to the wound.

MEDICAL ATTENTION WHEN NECESSARY SHOULD BE SOUGHT AS SOON AS POSSIBLE. IN ALL TYPES OF WOUNDS, TREATMENT FOR PREVENTION OF TETANUS SHOULD BE SOUGHT.

Burns and scalds

Cover the burn or scald with a sterilized burn dressing of suitable size.

Oil should not be used for a burn as it is usually not sterile and its use will interfere with any subsequent medical treatment.

Do not prick any blister.

Acid and Alkali burns

Acid: Thoroughly flood the burn with cold water. After flooding the burn, sprinkle it with powdered bicarbonate of soda, i.e., baking soda or carbonate of soda, i.e., washing soda.

Alkali: If the burn is caused by quicklime remove all evident traces from the burn.

Thoroughly flood the burn with cold water.

Bathe the burn freely with a weak acid solution such as lime juice or vinegar diluted with an equal volume of water.

APPLY A STERILIZED DRESSING TO THE BURN WHETHER CAUSED BY ACID OR BY ALKALI.

Contamination of the Eye and Foreign Bodies in the Eye

Contamination.—WASH EYE IN RUNNING WATER FOR 15 MINUTES *.

Foreign Body.—WASH EYE IN RUNNING WATER FOR 15 MINUTES*. DO NOT TRY TO REMOVE ANY PARTICLE WHICH CANNOT BE WASHED AWAY. IN SUCH A CASE MEDICAL ATTENTION SHOULD BE SOUGHT AT ONCE.

ALL EYE INJURIES SHOULD RECEIVE MEDICAL ATTENTION.

*Note.—For this purpose running water in jets directed upwards or an eye fountain is recommended.

Fractures—General Rules.—Attend to the fracture on the spot, and do not move the casualty until the part has been immobilised unless life is in danger from some other cause.

Prevent the fractured ends from moving by strapping them to the body with bandages. Do not apply bandages over the site of fracture or too tightly.

Support the infused part so that jarring and movement is prevented.

Injuries from Electric Energy

- (1) Switch off current.
- (1) Switch on current.
 (2) If it is impossible to switch off or break the current, remove the casualty from contact with the current. Great care is necessary. Dry insulating material such as rubber gloves, a thick coat or other garment should protect the rescuer's hands and body. If possible the rescue should stand on some insulating material such as rubber soled boots or shoes or a thick pile of dry newspaper.

Caution.—WITH VERY HIGH VOLTAGES THERE IS THE DANGER OF CURRENT ARCING i.e. JUMPING THE GAP THROUGH AIR OR INSULATIVE MATERIAL TO EARTH. IN THESE CASES POWER SHOULD BE SWITCHED OFF OR RESCUE LEFT TO TRAINED PERSONNEL.

(3) GIVE ARTIFICIAL RESPIRATION BY ANY CONVENIENT METHOD. IF THE CASUALTY IS NOT BREATHING NO TIME SHOULD BE LOST AS EVERY SECOND COUNTS.

Mouth to Mouth method.—Place casualty on his back. Hold his head in both hands. With one hand on his forehead press the head backward and with the other hand push the lower jaw upwards and forwards. Seal your lips round the lips of the casualty. A thin handkerchief may be interposed. Pinch the casualty's nostrils with your fingers sealing off the nostrils.

Blow into his lungs and watch for the chest to rise, then remove your mouth each time. Inflation should be at the rate of 10 per minute. The first 6 inflations should be given as quickly as possible.

(4) SEEK MEDICAL AID. ARTIFICIAL RESPIRATION SHOULD BE CONTINUED WHILE SEEKING MEDICAL AID.

Asphyxia.—Remove the casualty from the cause or remove the cause if possible.

RESCUER SHOULD BE WELL PROTECTED AGAINST ASPHYXIA HIMSELF. APPLY ARTIFICIAL RESPIRATION.

SEEK MEDICAL ATTENTION.
