Award

An industrial dispute between the above-named parties was referred to this Tribunal by the Commissioner of Labour under Section 3(1)(d) of the Industrial Disputes Act. Chapter 131, (1956 revised edition) as subsequently amended, for settlement by arbitration.

In the statement furnished in terms of Section 16 of the Industrial Disputes Act, Chapter 131, by the Commissioner of Labour, the matter in dispute was stated to be—

"Whether the transfer of Mr. N. M. Hameed from the Head Office of Liberty Cinemas Ltd. and Ceylon Entertainments Ltd., to the Films Stores Department situated at the Central Theatre premises, Maradana, with effect from 1st May, 1970, is justified and, if not, to what relief he is entitled"

This matter was taken up for inquiry on 15th July, 1970. Mr. N. Shanmugadasan represented the applicant-union while Advocate Mr. R. L. Jayasuriya instructed by Mr. M. M. A. Raheem appeared for the employers. The parties discussed the possibilities of a settlement of the matter in dispute and further hearing was postponed to 21st July, 1970.

On 21st July, 1970, the parties discussed further the possibilities of a settlement and the inquiry was postponed to 6th August 1970.

When this matter was taken up for inquiry on this date, parties stated that the matters in dispute have been amicably settled. It was stated that the workman, Mr. N. M. Hameed, who was transferred with effect from 1st May, 1970, to the Films Stores at 151, 1st Division, Maradans, is now transferred with effect from 15th August, 1970, to the Office of the Ceylon Entertainments Ltd., at 35, Dharmapala Mawatha, Colombo 3.

I consider the settlement just and fair and make my award accordingly.

In conclusion, I must state that this dispute would not have been resolved so quickly had it not been for the keen desire of both parties to have harmonious industrial relations. I, Therefore, thank Al. Haj. Jabir A. Carder, Managing Director of Ceylon Entertainments Ltd. and Liberty Cinemas Ltd., Advocate Mr. R. L. Jayasuriya and Mr. N. Shanmugadasan of the Union for bringing this dispute to an expeditious end.

Award

The Honourable the Minister of Labour and Employment by Order dated 10th February, 1968, referred this dispute, under section 4 (1) of the Industrial Disputes Act, between United Engineering Workers' Union, 123, Union Place, Colombo 2 and Tyrecraft Ltd., 266, Vauxhall Street, Colombo 2.

The statement of dispute by the Commissioner of Labour accompanying the Order of the Minister states the dispute in the following terms: "The matter in dispute between the aforesaid parties is whether the non-offer of work to the following employees who are members of the Union by the Management of Tyrecraft Ltd., is justified and to what relief each one of them is entitled." The statement of the dispute also contains the names of 66 workers. The respondent firm to the dispute filed its statement and the Union has replied to the statement.

At the inquiry Mr. Shanmugadasan appeared for the Union and Mr. Walter Jayawardena with Mr. Wanigasuriyar instructed by Mr. Gurusinghe appeared for the respondent.

A very 'arge volume of evidence has been led by the parties concerned and it will be relevant to consider the background of this dispute before coming to the actual events that led to the "non-offer" of work to the workers concerned. It appears from the evidence that some time in 1967 the Union wrote to the respondent R.1 making certain demands. R.1 is dated 6th January, 1967. The respondent's position seems to be that there was a Union already in existence in the work place known as Tyrecraft Workers' Union. It appears from the evidence led by the Union that friction started at the workplace after the United Engineering Workers' Union sent its letter R.1 and also it seems to be the position of the Management that they did not recognise the United Engineering Workers' Union. The Management's position is that the l'yrecraft Workers' Union was formed some time in 1966 and the evidence with regard to the formation of this Union is largely through the witness Alfred Wijesuriya, a working Director of the respondent firm. This witness is supposed to have gone abroad to learn the mechanics of retreading and re-building tyres. He clearly stated before this Tribunal that he has absolutely no knowledge of what a trade union is and that he was not interested in any union activities.

It appears from the evidence led that the Tyrecraft Workers' Union was registered and came into existence as a Union long after the writing of R.1 by the United Engineering Workers' Union. The evidence on this point given by the workers who gave evidence before this Tribunal and the evidence of an official from the Labour Department clearly supports the Union's contention that the Tyrecraft Workers' Union came into existence after R.1 was written. The evidence led by the Union seems to suggest that the Management was not in favour of trade unions being formed and, in fact, the formation of the Tyrecraft Workers' Union was a device employed by the Management to break up the United Engineering Workers' Union. The Union's contention is that from the beginning of 1967 the Management was devising ways and means of getting rid of the workers for the reason that they had joined the United Engineering Workers' Union. In fact the evidence of Wijesuriya was that there was no union whatsoever at the workplace and the first union that was formed was the Tyrecraft Workers' Union.

According to the statement filed by the respondent, the respondent takes up the position that the workers concerned in this dispute did not turn up for work after the 21st December, 1967, and as such the workers were informed that if they did not report for work on the 26th December, 1967, they would be deemed to have vacated their posts. Further, the respondent's position also is that after these workers went out on strike on the 21st December the plant and machinery of the respondent firm were found not to be functioning in proper order and the respondent alleges sabotage on the part of the workers concerned. The respondent has also taken up the position that the strike in which these workers indulged in was illegal and unjustified and also in view of the sabotage which the workers indulged in before they went on strike the respondent lost confidence on these workers and the respondent was justified in not offering work to the workers concerned.

The position of the Union seems to be different. The Union has led evidence that they had given notice of the strike and they went on strike together with other unions which went on strike demanding a general wage increase and once the

dispute was referred to arbitration to the Industrial Court the workers reported for work but work was not offered to them. It will be convenient at this stage to state that it is not in dispute that notice of the strike was given to the respondent and the workers went on strike as from the 21st December, 1967. The respondent's contention is that the strike is illegal. From the evidence that has been led it is quite clear that the workers concerned went on strike together with other union workers demanding a general wage increase. The legal position seems to be the workers can go on strike provided the strike is not in an essential service or if the strike was after the matter in dispute has been referred to an Industrial Court or Labour Tribunal for arbitration. It is clear from the evidence that the workers did go on strike apparently in response to the trade unions for a demand for higher pay and in the instant case notice of such strike was given to the Management and it follows from the evidence, which this Tribunal accepts, that the strike was perfectly legal and justified. dispute was referred to arbitration to the Industrial Court the justified

Tribunal accepts, that the strike was perfectly legal and justified.

The respondent's next position seems to be that these workers were guilty of sabotage and as such the respondent lost confidence on the workers concerned and because of that the respondent was justified in not offering work to the workers concerned. On the question of sabotage a large volume of evidence has been led by the respondent and by the workers concerned and it must be stated that the burden of proving sabotage without reasonable doubt is on the Management. The Management called the following witnesses in support of this charge of sabotage: Maurice de Mel, Chief Executive of the respondent firm, Alfred Wijesuriya, a working Director and certain workers. The evidence of de Mel was that on 21st December, 1967, the majority of the workers were on strike and that Alfred Wijesuriya also came to the work premises about the same time when both of them decided somehow or other to get the factory working. It appears from the evidence of Maurice de Mel that when one of the workers attempted to work one of the moulds the mould fell down, and this is also the evidence of Wijesuriya. It is also the evidence of Maurice de Mel that the machinery also was not functioning properly—like the central boiler and the hydraulic press. The workers who were called upon to start the machinery on the day in question support these two witnesses and the evidence of these two witnesses is that the bolts which held the moulds were not tightened properly. But none of these witnesses in any way stated that any one of the workers mentioned in the dispute was responsible for this state of affairs. It is also in evidence that on the day in question the Management had summoned an expert Engineer by the name of Mr. Ranjit Wijetilleke to examine the machinery and furnish a report. There is also reference to a foreign expert who was also summoned on the day in question. Both Mr. Ranjit Wijetilleke and the foreign expert referred to in the evidence before this Tribunal; inst evidence before this Tribunal; instead one Alagaratnam was called to give evidence and apparently Alagaratnam is a highly qualified Engineer. In his evidence Alagaratnam stated that he examined the machinery long after the alleged sabotage and in fact this witness stated that he examined the machinery about 8 or 9 days before he gave evidence before this Tribunal—that is almost a year after the alleged sabotage.

about 8 or 9 days before he gave evidence before this Tribunal—that is almost a year after the alleged sabotage.

The Union also led evidence of several workers and in fact one worker gave evidence to the effect that moulds have come down long before this strike and this particular worker was subject to lengthy cross-examination and it was suggested that the moulds came down because of his own negligence and not due to any fault of the machine. There was also evidence of other workers that moulds have come down on earlier occasions long before the sabotage as alleged by the respondent. Alfred Wijesuriya the working Director who gave evidence before this Tribunal has stated in evidence that he suspected sabotage on the part of the workers in the early part of 1967 but did not have evidence to prove this allegation. But the curious fact is that one of the witnesses, Vaas, who was called by the respondent stated clearly in evidence before this Triubnal that prior to 21st December, 1967, he was called to effect repairs to the motors in the factory and at no time was sabotage alleged by the Management. It is also in evidence that the workers who gave evidence in support of the Management have clearly stated that they did not suspect or even accuse any of the workers to the dispute as being responsible for this shortage. It is also in evidence that when the Management tried to get the factory started on the day of the strike most of the workers in the factory were apprentices and learners except for one or two permanent workers. The Tribunal has given its mind to the evidence on this question of sabotage. The respondent management has led considerable evidence on this subject and the workers have The Tribunal has given its fining to the evidence on the question of sabotage. The respondent management has led considerable evidence on this subject and the workers have also given evidence and the Tribunal comes to the finding that the Management has not proved beyond doubt or even on the balance of probability that these workers concerned were responsible for the shortage they allege.

The Tribunal also comes to the finding that the strike on 21st December, 1967, by the workers concerned was a perfectly justified strike which the workers were entitled to within the law of this country and also that they reported for work after the dispute was referred to the Industrial Court. There is also evidence that these workers reported for work two or three days after the strike was called off.

Mr. Nagalingam, Assistant Secretary of the Employers' Federation gave evidence to the effect that all the unions under the Employers' Federation who went on strike during this period reported for work and work was offered to them.

It is also in evidence that the Management further put up a notice (R.11) that 40 of these workers whom the Manageup a notice (R.11) that 40 of these workers whom the Management described as permanent workers (R.10) should not enter the work premises and in R.12 the Management sought permission from the Industrial Court by an interim application to terminate the services of the workers concerned. It seems that the Management has not pursued this application. On the evidence placed before this Tribunal it is clear that the Industrial Court did not adjudicate at all on this application of the Management. of the Management.

of the Management.

It is very necessary for this Tribunal to observe that from the evidence placed before the Tribunal that it is very surprising to find a working Director of an old established firm to state before this Trbunal that he is not interested in trade union activities and in fact has no knowledge of what a trade union is. It is a sad reflection for a working Director of firm to express these sentiments before a Tribunal and particularly in an age when trade unionism is fully recognised in all sectors of organised industry, both public and private, in all parts of the world.

This Tribunal has considered all the evidence, both docuentary and oral, placed before it and comes to the conclusion that the "non offer" of work to the workers in the statement of dispute, as filed by the Commissioner of Labour, is not justified and the workers are entitled to relief.

The question of relief is one of difficulty. It is clear from the evidence that there is no cordial relationship between the Management and the workers in this workplace. The Management has made various allegations against these workers and the workers in turn have made allegations against the Management and in fact some of the workers who gave evidence before this Tribunal have alleged that they have been indiscriminately assaulted by the working Director Wijesuriya.

In the circumstances of this case I order that the workers In the circumstances of this case I order that the workers named in the list marked X for the sake of convenience, that is the 40 workers, be paid compensation as follows: Workers who have worked over 20 years be paid 5 years' salary as compensation; workers who have worked over 10 years be paid 3 years' salary as compensation; workers who have worked over 10 years be paid 3 years' salary as compensation and paid 3 years' salary as compensation; workers who have worked over 5 years be paid 2 years' salary as compensation and workers who have worked under 5 years be paid one year's salary as compensation to be calculated according to the sums indicated in the last column in list X or, in the alternative, the workers concerned in the list marked X be reinstated with back wages fixed at one year's salary also to be calculated according to the sums indicated in the last column in the list marked X.

List marked X has been accepted by the Union and it contains the names of 40 workers. The position of the respondent is that these 40 workers were permanent workers and the rest were temporary workers and no evidence has been led to the contrary by the Union. In the circumstances the workers whose names appear in the statement of dispute, whose names are not included in the list marked X by the respondent, are apparently temporary workers. In the case of the temporary workers I recommend to the Management that they be re-employed if there are vacancies in the workplace or, in the alternative, to pay 3 months' salary to each of them as ex-gratia payment.

The respondent will either reinstate the workers with back

The respondent will either reinstate the workers with back wages fixed at one year's salary or pay compensation as indicated below against each worker within one month of the publication of this Award.
