Trade Marks limited to Colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to

certain colours, the colours are, as far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner.

Association

Where it is stated that an advertised mark is to be associated under Section 22 of the Trade Marks Ordinance (Cap. 121) with another mark, it is indicated by its official number.

Application in Part A or P rt B

Applications for registration in Part A of the Register are shown with the official number unaccompanied by any letter. Applications for Part B of the register are distinguished by the letter B pr fixed to the official number.

OPPOSITION

NOTICE is hereby given that any person who has grounds of objection to the registration of the following trade marks may, within two months from the date of this Gazette, lodge Notice of Opposition on form T. 
