## THE HANGURANKETA ESALA PERAHERA Notilication

BY virtue of the powers vested in me by regulations 1 and 2 of the regulations applicable to pilgrimages relating to the Esala Perahera at Hanguranketa, and published in *Gazette* No. 10,232 of 6th April, 1951, I, Felix R.
