Order No. 296

BY virtue of the powers vested in me by section 4 (1) (i) of the Food Control Act (Chapter 171), I, Pahala Rallalage Ratnayake, Acting Minister of Foreign and Internal Trade, do by this Order, prohibit the transport or removal of any quantity of Red Onions to the Jaffna Peninsula.

In this Order, "Jaffna Peninsula" means the Administrative District of Jaffna, exclusive of the Divisional Revenue Officer's Division of Karachchi-Thunukkai.

THE FOOD CONTROL ACT (CHAPTER 171) OF THE LEGISLATIVE ENACTMENTS OF CEYLON

Order No. 297

BY virtue of the powers vested in me by section 4(1) (i) of the Food Control Act (Chapter 171), I, Pahala Rallalage Ratnayake, Acting Minister of Foreign and Internal Trade, do by this Order—

- (1) prohibit the transport or removal without a permit from the Deputy Food Controller, Jaffna District, of any quantity of Red Onions except for seven pounds taken by any person-
 - (a) by boat or sailing vessel from any point of the sea or lagoon coast around the Jaffna Peninsula;
 - (b) from the Jaffna Peninsula;
 - (c) in the D. R. O's Division of Pachchilaipallai;
 - (d) in the Village Headman's Division of Maravanpulavu and Tanankilapu in the D.R.O's Division of Tenmaradchy.
- "Jaffna Peninsula" for the purpose of this Order means the Administrative District of Jaffna, exclusive of the Divisional Revenue Officer's Division of Karachchi-Thunukkai.

THE FOOD CONTROL ACT (CHAPTER 171) OF THE LEGISLATIVE ENACTMENTS OF CEILON Order No. 298

BY virtue of the powers vested in me by section 4 (1) (i) of the Food Control Act (Chapter 171), I, Pahala Rallalage Ratnayake, Acting Minister of Foreign and Internal Trade, do by this Order, prohibit the transport or removal of any quantity of paddy containing an admixture of coloured grains of paddy from any one place in Ceylon to any other place in Ceylon except under the authority of a permit issued by or on behalf of the Food Controller or Deputy Food Controller or Assistant Food Controller of the area within which the first mentioned place is situated or otherwise than in accordance with such conditions as may be attached to such permit;

Provided that nothing in the preceding provisions of this Order shall apply—

- (a) to the transport or removal of any quantity of such paddy by any person on behalf of the Government of Ceylon; or
- (b) to the transport or removal by a registered rice miller, or any person on behalf of such miller, to the store or place of business of such miller of such quantity of paddy as issued to such miller by the Department of Agrarian Services.

In this Order-

- "Coloured grains of paddy" means grains of paddy artificially coloured with "Malchite green" or
- "Cochin Scarlet" or with any other substance or ingredients which produces green or red colour when applied to grain⁸ of paddy; and
- "Registered rice miller" means a person who is for the time being registered by the Commissioner of Agrarian Service⁸ for the purpose of milling Government paddy for fee or reward.

THE FOOD CONTROL ACT (CHAPTER 171) OF THE LEGISLATIVE ENACTMENTS OF CEYLON

Order No. 299

BY virtue of the powers vested in me by section 4(1) (iv) of the Food Control Act (Chapter 171), I, Pahala Rallalage Ratnayake, Acting Minister of Foreign and Internal Trade, do by this Order prohibit the removal from the Customs premises at any port or place mentioned in the first column of the Schedule hereto, of any rice, paddy, wheat, wheat flour or kurakkan, except under a permit issued by the person or any of the persons, as the case may be, mentioned in the corresponding entry in the second column of that Schedule, and except in accordance with such directions as he may issue in regard to the time at which, the manner in which and the place to which such rice, paddy, wheat, wheat flour or kurakkan may be so removed.
