### Price Orders

#### THE CONTROL OF PRICES ACT

##### Order under Section 4

BY virtue of the powers vested in me by section 4 of the Control of Prices Act (Chapter 173), I, Kiri Banda Dissanayake, Controller of Prices (Miscellaneous Articles), do hereby amend Column 1 of Schedule "B" of the Control of Prices (Imported Textiles) Order No. 4 of 1970 published in the English Language and appearing on page 524/13 of *Gazette Extraordinary* No. 14,919/7 of 20th August, 1970, by the substitution for all the words "Imported Textiles (to be sold only on the surrender of valid coupons or textile tokens)" of the following:—

"Imported Textiles (to be sold only without the surrender of Coupons or textile tokens)".

2. This order may be cited as the control of Prices (Imported Textiles) Order No. 5 of 1970.
