## THE VILLAGE COUNCILS ORDINANCE

#### 0.44

BY virtue of the powers vested in me by sections 5 and 10 of the Village Councils Ordinance (Chapter 257), I, William Neal de Alwis, Acting Minister of Public Administration, Local Government and Home Affairs do by this Order—

- (1) divide the Karaitivu village area in the Jaffna District, Northern Province into two new village areas of Karainagar north and Karainagar south more fully described in the Schedule hereto; and
- (2) appoint the first day of January, 1971, as the date on which the term of office of each Village Council to be constituted for the aforesaid village areas of Karainagar north and Karainagar south shall commence.

# SCHEDULE

- (1) Karainagar north village area comprising the Grama Sevaka Division No. 10 A Karainagar north and such parts of the Gramasevaka Divisions No. 9, Karainagar west and No. 10 Karainagar East as are situated to the north of a straight line drawn due eastwards to join the Centre line of Kallanthalvu channel near Odaitheru at its bend towards north, thence south eastwards along the Centre line of the said channel till it meets the Centre line of the Circular road, thence Southwards along the centre line of the said road till it meets a point in line with Veratkulam thence eastwards along a straight line to Veratkulam, thence eastwards, north eastwards along the centre line of the Kalavil channel and a prolongation thereof to the sea.
- (2) Karainagar south village area comprising such parts of the Grama Sevaka Divisions No. 9 Karainagar west and No. 10 Karainagar east as are situated to the south of a straight line drawn due eastwards to join the centre line of Kallanthalvu channel near Odaitheru at its bend towards north, thence south eastwards along the Centre line of the said channel till it meets the Centre line of the Circular road, thence Southwards along the centre line of the said road till it meets a point in line with Veratkulam, thence eastwards along a straight line to Veratkulam, thence eastwards, north eastwards and south eastwards along the centre line of the Kalavil channel and a prolongation thereof to the sea.

# THE VILLAGE COUNCILS ORDINANCE

BY virtue of the powers vested in me by section 8 of the Village Councils Ordinance (Chapter 257), I, William Neal de Alwis, Acting Minister of Public Administration, Local Government and Home Affairs do by this Notification—

- (1) sub-divide the combined area of the existing wards situated in the village area of Karainagar north in the Jaffna District, Northern Province, as are specified in Column 1 of the First Schedule hereto into the new wards with the limits specified in the corresponding entries in Column II of that Schedule;
- (2) sub-divide the combined area of the existing wards situated in the village area of Karainagar South in the Jaffna District, Northern Province, as are specified in Column I of the Second Schedule hereto into the new wards with the limits specified in the corresponding entries in Column II of that Schedule; and
- (3) declare that the provisions of paragraphs (1) and (2) of this Notification shall-
  - (a) in so far as those provisions relate to any matter connected with the general election of the members of the village Council of each of the aforesaid Village areas of Karainagar north and Karainagar South to be held in the year 1970, come into effect on the day on which this Notification is published in the Gazette; and
  - (b) in so far as those provisions relate to any other matter, come into effect on the first day of January, 1971.

East—By a line drawn from the last-mentioned point southwards along the Centre line of Sivakamiamman Kovil road with Circular road,

South—By a line drawn from the last mentioned point westwards along the Centre line of Circular road to Alady junction,

West—By a line drawn from the last mentioned point northwards and north westwards along the Centre line of Kovalam road to the Centre of its junction with Mullapularu road, thence northwards along the Centre line of that road to the starting point of the northern limit of the ward.

#### Ward No. 3-Viklavil

North—By a line drawn from the Centre of the junction of Sivakamiamman Kovil road and Alanthanai-Meihandan Padasalai road eastwards along the Centre line of the latter road to the Centre of its junction with Allin Veethy,

East—By a line drawn from the last-mentioned point southwards along the Centre line of Allin Veethy to its junction with Circular road,

South—By a line drawn from the last-mentioned point westwards along the Centre line of Circular road to the Centre of its junction with Sivakamiamman Kovil road,

West—By a line drawn from the last mentioned point northwards along the Centre line of Sivakamiamman Kovil road to the starting point of the northern limit of the ward.

# Ward No. 4-Sithamparamoorthy Kerniady

North—By a line drawn from the northern extremity of the northern limit of ward No. 1 eastwards along the northern limit of the Village area till it meets a line drawn north eastwards in prolongation of the Centre line of the lane extending from the Cemetery road,

East—By a line drawn from the last-mentioned point south westwards along a straight line drawn to meet the Centre line of the lane extending from Cemetery road and continuing along the Centre line of that lane to its junction with Cemetery road, thence south eastwards along the Centre line of Cemetery road to its junction with Sivan Kovil road, thence southwards along the Centre line of Sivam Kovil road to the Centre of its junction with Circular road,

South—By a line drawn from the last mentioned point westwards along the Centre line of Circular road till it meets the eastern limit of ward No. 3,

West—By a line drawn from the last-mentioned point northwards and westwards along the eastern and northern limits of Ward No. 3, thence northwards along the eastern limit of Ward No. 2 to its northern extremity, thence westwards along the northern limit of Ward No. 2 till it meets the eastern limit of Ward No. 1, thence northwards along the eastern limit of Ward No. 1 to the starting point of the northern limit of the ward.

# Ward No. 5-Neelipanthanai

North—By a line drawn from the starting point of the eastern limit of Ward No. 4 north eastwards along the northern limit of the village area till it meets a point in prolongation of the Centre line of Casurina Beach lane,

East—By a line drawn from the last mentioned point southwards along a straight line to the Centre line of Casurina Beach lane and in continuation of that line along the Centre line of the said lane to its junction with Nadutheru Mallikai lane thence southeastwards, southwards, southwards and aagin southwards along the centre line of Nadutheru Mallikai lane to the Centre of its junction with Circular road,

South—By a line drawn from the last-mentioned point westwards along the Centre line of Circular road till it meets the eastern limit of Ward No. 4,

West—By a line drawn from the last-mentioned point northwards along the eastern limit of Ward No. 4 to its northern extremity.

# Ward No. 6-Mapana Oori

North and East—By a line drawn from a point at the northern extremity of the eastern limit of Ward No. 5 eastwards and southwards along the northern and eastern limits of the Village area till it meets a point in prolongation of Muthali Kerniyady lane,

- South.—By a line drawn from the last mentioned point westwards along the Centre lines of Sinnalady lane and Paththar Kandy lane till it meets Odaitheru, thence westwards along Odaithoru till it takes a turn to-wards north along the Beach, thence westwards along a straight line to the western limit of the Village Area.
- West.—By a line drawn from the last-mentioned point northwards along the western limit of the village area to the starting point of the northern limit of the ward.

#### Ward No. 9-Thangodai.

- North.—By a line drawn from the western extremity of the southern limit of ward No. 8 eastwards along that limit to its eastern extremity.

- South& West.—By a line drawn from the lastmentioned point westwards and north westwards along the southern limit of the village area to the starting point of the north thern limit of the ward.

- East.—By a line drawn from the last-mentioned point southwards along the Centre line of the lane and continued to meet the Centre line of the Channel, thence eastwards and southwards along the Centre line of the Channel till it meets the southern limit of the village area.

- West.—By a line drawn from the last-mentioned point northwards along the Centre line of the Circular road to the starting point of the northern limit of the Ward.

- North,—By a line drawn from the northern extremity of the western limit of Ward No. 1 south eastwards along that limit and north eastwards and eastwards along the southern limit of ward No. 1 till it meets the western limit of Ward No. 2.

  - (a) by the substitution, for the description of the limits of Ward No. 9, of the description set out in Schedule A hereto;
  - (b) by the omission of all particulars relating to ward No. 10;
  - (c) by the substitution, for the description of the limits of Wards Nos. 12, 13 and 17, of the description of new Wards Nos. 10, 11 and 15 set out in Schedule B hereto;
  - (d) by the renumbering of wards Nos. 14, 15, 16, 18, 19, 20, 21, 22, 23, and 24, as wards Nos. 12, 13, 14, 16, 17, 18, 19, 20, 21 and 22 respectively; and
- (2) declare that the provisions of paragraph (1) of this notification shell-
  - (a) in so far as those provisions relate to any matter connected with the general election of members of the Village Council of the aforeasaid village area to be held in the year 1970, come into effect on the date on which this Notification is published in the Gazette; and
  - (b) in so far as those provisions relate to any other matter, come into effect on the day immediately following the date of expiration of the term of office of the members of the Udupiddy Village Council who are in office at the date hereof.
