THE WELISARA TOWN COUNCIL The Entertainment Tax Ordinance

THE following resolution passed by the Welisara Town Council under sub-section (1) of section 2 of the Entertainment Tax Ordinance (Chapter 267), has been approved by the Minister of Public Administration, Local Government and Home Affairs, and is published in terms of sub-section (2) of that section.

RESOLUTION

" This Council, under sub-section (1) of section 2 of the Entertainment Tax Ordinance (Chapter 267), hereby imposes and levies with effect from the date on which this resolution is published in the *Gazette*, a tax at the rates set out hereunder on payment for admission to entertainments (as defined in that Ordinance) held in the area within the administrative limits of the Council.
