RULES made by the Minister of Post and Telecommunications under section 13 of the Telecommunications Ordinance (Chapter

Ship to Shore Radio Telephone Rules

- These rules may be cited as the ship to Shore Radio Telephone Rules, 1970.
- 2. Radio telephone services shall be available between telephone subscribers in Ceylon and any suitably equipped ships at sea or in harbour, during such periods of the day or ships at sea or in harbour, during such periods of the day or night and at such rates as are specified in the Schedule hereto.
 - 3. A shore to ship radio telephone call may be booked-
 - (1) (a) as an ordinary call, that is to say, a call from any specified telephone number to any suitably equipped ship at sea or in harbour, only the calling number and the name of the ship being recorded;

- (b) as a personal call, that is to say, a call from a specified person at the calling number to a specified person in the called ship.
- (2) A caller booking a personal call shall have the option of naming a substitute for himself and a substitute for the specified person at the called ship as an alternative.
- (3) In the case of an ordinary call, the first unit period of conversation shall be deemed to commence at the moment when the calling number or ship is placed in communication with the called number or ship as the case may be and in the case of a personal call, at the moment when the caller or his named substitute is placed in communication with the called caren of is placed in communication with the called person or that person's substitute.
- 4. All call bookings shall remain valid for forty-eight hours unless refused by the called person or cancelled by the caller.

- 5. No call originating from a subscriber's own telephone in Ceylon shall be put through unless the subscriber has deposited as security with the Post Office exchange with which his telephone is connected for Overseas Telephone calls the following amounts:
 - (a) in the first instance, a sum of Rs. 150, and,
 - (b) where the daily average charge payable by that subscriber calculated over a period of one week exceeds Rs. 150, such further sum as may be necessary to make the deposit equal to that average.
- 6. (1) Every call of a duration of three minutes or less shall be charged as for three minutes. In the case of calls whose duration exceeds three minutes, a charge per minute shall be made for the period in excess of three minutes, any fraction of a minute being charged as for one minute. The enarge per minute, after the first three minutes shall be one third of the charge for the first three minutes.
- (2) There shall be no prescribed maximum period for any call: Provided, however, that in case of pressure of traffic, calls may be limited to six minutes enargeable time.
- (3) No caller shall be permitted to engage the ship to shore radio telephone service for more than one call at a time to the exclusion of any other caller who may desire to use the service.
- (4) The duration of a call may be limited to six minutes if it is necessary in order to meet a request for a higher priority call.
- (5) Where the duration of a call is limited, the caller shall be so informed, if possible at the time when the call is about to be connected; the caller and the called person shall also, if possible, be so advised a few seconds before the disconnection of the call.
- (6) The decision of the Director of Telecommunications or an officer authorised in that beneat by the Postmaster-General as to the duration of a call, shall be final.
- 7. (1) In lieu of the fee chargeable for an effective personal call on the ship to shore radio telephone service, a report enarge shall be payable in respect of a personal call in the following cases:—
 - (a) Where the call is abandoned after communication has been established with the sinp, and the catter, or failing him someone at his telephone is notined, that neither the called person nor that persons substitute is available to speak;
 - (b) Where at the time when the call is ready to mature with the called snip, the caller or the called person is not available, or is unwilling to speak, or there is no reply from the caller or called snips telephone and the call is cancelled;
 - (c) Where the called person is not in the ship and arrangements were made for him to come to a specified sinp's telephone number and communication is not established owing to failure to secure his presence at such sinp's telephone or the call is cancelled before he comes.
- (2) No report charge shall be levied in any case where the booking is cancelled—
 - (a) by the caller before report on it has been given to him or communication is established with any person at the called ship; or
- (b) by the telephone exchange owing to service defects or unsatisfactory transmission or the prior connection of an incoming call (called a cross-call) between the same parties, or unintentional duplication of booking by the caller.
- (3) The decision of the Director of Telecommunications as to when a report charge is payable shall be must.
- 8. (1) Towards the end of each three minute period of effective conversation, the operator shall announce to the caller the number of nimutes of effective conversation the caller has had at the end of that period.
- (2) Conversation shall not otherwise be interrupted at all unless an interruption is necessary for the purpose of the service, and the caller may end or extend the call as ne wishes without being specifically asked by the operator whether an extension is desired: Provided however, that where a caller booking a call requests that such call be limited to a specified number of chargeable minutes (subject to a minimum of three chargeable minutes) the operator shall terminate the connection as soon as the caller has had the specified period of effective conversation, unless at the end of such period the caller definitely asks for a further extension.
- 9. (1) In the case of a call made from a call office, the period of conversation required shall, in every case, be booked in advance, and no extension shall be given at the end of such period at the request of the caller, unless he has already deposited the appropriate fee for a further period of conversation, and where a caller terminates his conversation before the full period so booked by him expires, he shall be charged for the actual leriod of effective conversation he has had of for the first unit period of effective conversation, whichever of these is the longer.

- (2) In the case of a call made from a call office, there shall be no call office fee and the charges due on the call shall be prepaid: Provided however, that where the controlling exchange is not in a position to quote in advance the actual charge payable, the caller shall be required to deposit any reasonable sum, and any difference between such deposit and the actual charges due from him shall be paid or recovered from him, as the case may be, at the conclusion of the call.
- 10. (1) The disturbance fee prescribed in rule 10 of the Island Telegraph Rules, published in *Gazette* No. 8,360 of March 25, 1938, as amended subsequently, shall be payable on every ship to shore radio telephone call made from and through any Telephone Exchange or Call Office in Ceylon which is closed during any part of the working period of the ship to shore radio telephone service.
- (2) No disturbance fee shall be payable on any call referred to in paragraph (1) where only a report charge is due, or when a call is ineffective owing to service or other reasons.
- 11. (1) Bills on account of ship to shore radio telephone calls shall be rendered daily.
- (2) If a bill is not settled within three days from the date on which it is rendered, ship to shore radio telephone facilities shall be withdrawn without further notice. Indian and inland trunk facilities may also be withdrawn until any outstanding ship to shore radio telephone account is settled, in addition to any other steps the Director of Telecommunications may take under the relevant conditions in the Telephone Agreement.

A, 35/1, Horton Place, Colombo 7, of the other part was referred by Order dated September 6, 1969, made under Section 4 (1) of the Industrial Disputes Act, Chapter 131 as amended and published in Ceylon Government Gazette No.14,872 of September 19, 1969, for, attlement by arbitration is hereby published in terms of Section 18 (1) of the said Act.

Award

The Commissioner of Labour, being satisfied that an industrial dispute exists between the workmen who are members of the Jathika Sevaka Sangamaya, a Trade Union (hereinafter called "the Union") and their four employers, namely: (1) Stirling Astaldi Ltd., (2) Mr. C. G. Gibson, Chief Administrative Officer, Stirling Astaldi Ltd., (3) Mr. U. Pierini, Sub Agent, Stirling Astaldi Ltd., all of Petroleum Refinery Site, Sapugaskande, and (4) Snam Progetti S. P. A. of 35/1, Horton Place, Colombo 7, the Honourable the Minister of Labour and Employment, who was of the opinion that it was a minor dispute, referred it for arbitration to me by his Order dated 6th September, 1969, under Section 4 (1) of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon 1956 Revised Edition, as since amended, together with the Commissioner's Statement of the matter in dispute in he following

"The matter in dispute between the aforesaid parties is whether the termination of the services of the employees referred to in the attached schedule, who are members of the aforesaid Union, is justified, and to what relief each of them is entitled."

(The Schedule of names referred to above is incorporated in 'X4' annexed).

The parties referred to in the Statement are the Union and the Employers mentioned above and the Schedule is the list of the

names of workmen seeking relief in this dispute.

The above matter in dispute, dealt with in this Award, is the same as that in Case No. A. 840 of 1969, in which I have already made my award in favour of the workmen therein concerned. Different workmen are involved in this arbitration. Of the Employers in this case, the First, Second and Third are different, the Fourth being identical with the Third Employer in Arbitration A. 840.

These two matters under arbitration in A. 840 and A. 841 were taken up for inquiry at the same time.

The preliminary objection taken in arbitration A. 840 was take in this arbitration also. For the same reason I over-ruled this objection in Arbitration A. 840, I over-ruled it in this matter A. 841 also.

At the ex parte hearing on June 1, 1970, evidence placed in respect of this dispute was that of the witness B. L. Gunasekera, supported by the evidence of S. D. S. Fonseka, the President of the Jathika Sevaka Sangamaya, the Union representing the party of workmen in this dispute.

PART I : SEC. (I) — (GENERAL) — CEYLON GOVERNMENT GAZETTE — Nov. 20, 1970

The witness B. L. Gunasekera is the 65th workman named in the Schedule. He produced the letter A1 which sets out the Conditions of his Employment. He was employed on behalf of the First Employer herein named, he said. He produced A2 which shows that he had been employed for the First Employer from 11.2.1968 to 1.4.1969. He had been dismissed on 1.4.1969.

According to the evidence of the witness S. D. S. Fonseka, he was also an employee of these four Employers whom they served in their employments for varying periods and were summarily dismissed on various occasions.

For the reasons which I stated in my Award in the Arbitration A-840, and on the evidence and documents placed in respect of the dispute in the instant case, I held that the dismissal of the workmen listed in X4, reproduced in the said Schedule annexed hereto, was not justified and that these workmen are entitled to relief.

The relief asked for is one month's pay in lieu of notice and a month's pay as gratuity. This is a modest claim for relief.

I award each of the workmen in the list X4 the amount of one month's salary he was in receipt of at the time of his dismissal, in lieu of notice and an equal amount as gratuity for service rendered by them in their employments, the aggregate of which amounts are stated in the last column of X4 subject to correction of any errors in these totals.

In addition to the costs awarded in A-840, I also award in this case A-841 further costs in a sum of Rs. 525 against the Employers, payable to the Union.

The above sums shall be payable to the persons and the Union to whom they are awarded by the Assistant Commissioner of Labour, Colombo North, on receipt of same from the aforesaid First, Second, Third and Fourth Employers who shall pay the said amounts or cause them to be paid to the said Assistant Commissioner of Labour (Colombo North) jointly or severally, on or before thirty first day of October, 1970.

THE INDUSTRIAL DISPUTES ACT, CHAPTER 131

THE Award transmitted to me by the Arbitrator to whom the industrial dispute which had arisen between Jathika Sevaka Sangamaya, 532, Galle Road, Colombo 3, of the one part and Snam Progetti-Division Saipem; Mr. G. Maletti, Administrative Officer, Snam Progetti-Division Saipem, all of Petroleum Refinery Site, Sapugaskanda, and Snam Progetti, S.P.A., 35/1, Horton Place, Colombo 7, of the other part, was referred by Order dated September 6, 1969, made under section 4 (1) of the Industrial Disputes Act, Chapter 131, as amended and published in Ceylon Government Gazette No. 14,872 of September 19, 1969, for settlement by arbitration is hereby published in terms of Section 18(1) of the said Act.

The Jathika Sevaka Sangamaya, No. 532, Galle Road, Colombo 3, of the one part,

and

Snam Progetti-Division Saipem, and Mr. S. Maletti, Administrative Officer, Snam Progetti-Division Saipem,

all of Petroleum Refinary Site, Sapugaskande,

and

Snam Progetti, S.P.A., 35/1, Horton Place, Colombo 7, of the other part.

Award

The Commissioner of Labour, being satisfied that an industrial dispute exists between the workmen who are members of the Jathika Sevaka Sangamaya, a trade union (hereinafter referred to as the Union') and, their three employers, namely (1) Snam Progetti-Division Saipem, (2) Mr. C. Melletti, Administrative Officer, Snam Progetti-Division Saipem, and (3) Snam Progetti, S.P.A., 35/1, Horton Place, Colombo 7 (hereinafter referred to as the first, second and third employers' respectively, purely for reference purposes.) The Honourable the Minister of Labour and Employment, who was of the opinion that it was a minor dispute, referred it to me for arbitration by his order dated 6th September, 1969, under section 4 (1) of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon, 1956 Revised Edition, as amended.

The Commissioner's Statement of August 23, 1969, sets out the matter in dispute between the aforesaid parties—

"whether the termination of the services of the employees referred to in the attached schedule, who are members of the aforesaid union, is justified and to what relief each of them is entitled;"

(The Schedule of names is incorporated in "X3" attached hereto.)

When the inquiry into this matter was taken up (two previous dates of inquiry having been postponed), the learned Counsel who appeared for Snam Progetti S.P.A., the third employer, Mr. Advocate N. Satyendra, objected to the validity of the Hon'ble Minister's Order referring this matter for arbitration and hence to the jurisdiction of the Arbitrator to inquire into the dispute. In stating the ground of his objection, the learned Counsel for the third employer alleged that the first and second employers to this matter (who had not tendered any Statement of their Case under Regulation 21(1) of the Industrial, Disputes Regulations, 1958, and who did not appear and were not represented before Court on this date), were not employers, relying on the statement of the Case for the Union in support of that allegation; that therefore there was no industrial dispute which concerned the first and second employers. Referring to the definition of 'industrial dispute' in the Industrial Disputes Act, he contended that the opposing parties to the Industrial Dispute must be constituted of workmen on the one hand and employers of such workmen on the other hand.

I appreciate the soundness of this contention as to what constitutes an industrial dispute as defined by the Act, and that an industrial dispute so constituted is the prerequisite of a reference for arbitration. However, I overruled this objection as one which cannot be entertained at the stage of arbitration, holding that the allegation of non-existence of an industrial dispute is not one which can be inquired into at this Inquiry, by virtue of the fact that the Commissioner was satisfied that an Industrial dispute exists between these opposing parties specified by him. Indeed every one who is included in an industrial dispute as an employer is estopped at the inquiry in arbitration from denying that he is an employer of any workman specified in the reference to arbitration.

With this preliminary objection overruled, inquiry into the matter in dispute was fixed for May 23, 1970. Counsel for the third employer on that date withdrew from the Inquiry stating that he had no instructions from the third employer and that therefore he was not appearing. At this stage none of the employers were present.

The Counsel for the Union, Mr. Advocate Krishnarajah, explained his case for the workmen and applied for an adjournment to place evidence ex parte in support of the case of the Union. I fixed the Inquiry for ex parte hearing on June 1, 1970.

At the ex parte inquiry on June 1, 1970, H. G. Basil Silva, the 87th workman in the schedule referred to in the Commissioner's Statement of dispute, and S. D. S. Fonseka, the President of the Union representing these workmen, gave evidence.

Counsel for the Union submitted that the evidence of H. G. Basil Silva was typical of the evidence of all the other workmen named in the Schedule, differing only in the dates of employment and dismissal. This witness, according to his evidence, was employed by the first-named employer. He produced the letter of employment marked A1. The employment was temporary. His salary was fixed at Rs. 4.90 a day. He received his salary at the end of the month computed on Rs. 4.90 a day. He had to report for work daily. He could not absent himself from work without applying for and obtaining leave. He was not told by his employers the duration of his employment. This employment entailed the contribution to employees Provident Fund (E.P.F.) by his employers in respect of his employment. On an average he was in receipt of a salary of Rs. 121 a month.

The third named employer, in its statement setting out its case in respect of this dispute has admitted that the workmen named in the Schedule referred to in the Commissioner's Statement of the dispute were its employees. No statements have been made regarding this dispute by or on behalf of the Firstor second-named employers, who in fact, did not present themselves for this Inquiry. In the circumstances these two

employers have not denied that the workmen named in the said Schedule were their employees. This conduct of the 2nd and 3rd employers in not being present at inquiry and not denying this, amounts to an admission that these workmen were their employees—even though a denial would not have availed them at this inquiry, prevented as they are from so doing. The denial, by the third-named employer, of the status of employer to these workmen in the second and first employer was inappropriate and designed, I belive, to obstruct this inquiry.

The construction of the Refinery at Sapugaskande was an engagement carried out by these employers who are three aspects of a single employer, with a unity of interest in accomplishing that engagement, the second-named employer being the Administrative Officer of the first-named employer, which was the medium used by the third-named employer to put into operation the engagement contracted for by it.

The witness H. G. Basil Silva was employed as a labourer at Sapugaskande, the site of the Refinery construction. According to his letter of employment A1 his employment was temporary. It is clear from this letter, that the employment of H. G. Basil Silva (who is one of the workmen listed in the said Schedule and evidence by the document X3 produced by the witness S. D. S. Fonseka, the President of the Union) required him to keep to certain hours of work, be regular in his attendance at work, and not to keep away from work without leave obtained previously; it carried a warning that his services would be dispenced with if his conduct or work was unsatisfactory. His salary was fixed at Rs. 4.90 for a day. This witness was also required by this letter to furnish particulars of any of his next of-kin to whom information could be given in case of illness or emergency affecting him.

This letter Al amply bears out that witness H.G.Basil Silva was not a casual worker, uncertain or unsecured of his employment for the next day or moment, though the construction of the Refinery in which he was employed was an enterprise characteristically limited in time, both contractually and by its nature.

This kind of enterprise providing sources of employment is not unusual. In truth, all engagements of mankind are generally limited by time; the duration of any enterprise varies for various reasons. It is confused thinking or disnonesty to describe an employment as temporary merely because the cource of employment is limited by time however comparatively short or long.

I am convinced that this witness H. G. Basil Silva was a workman reliably employed upon the assurance of a secure and certain employment so long as the source of employment lasted—provided he did nothing to detract from the reliability attributed to him. There is no evidence that he was wanting in such reliability, when he was summarily dismissed on March 24, 1969, according to letter A2.

The evidence of the witness S. D. S. Fonseka, the President of the Union, and that of witness H. G. Basil Silva establish sufficiently that the workmen including the witness H. G. Basil Silva in document X3 reproduced in the Schedule were employed at various times by the three Employers aforesaid who were served by them in their respective capacities of employment for various periods before they were dismissed summarily at different times.

I am presuaded by all the circumstances, documents and oral evidence placed before me at this inquiry that the dismissal of all these workmen in the list marked X3 reproduced in the said schedule was not justified and that these workmen are entitled to relief.

With regard to the relief, they ask for one month's salary as gratuity for their services and one month's salary in lieu of notice of dismissal. This in my opinion is a very modest claim for relief and extremely just and advantageous to the employers concerned in this dispute.

I accordingly award each of the workmen named in the list marked X3 the amount of the month's salary, he was last in receipt of, in lieu of notice of dismissal, and an equal amount as gratuity for service in this employment, computing the amount of such monthly salary on the basis of the daily rate multiplied by 26 (days). The aggregate amount thus due to each of the workmen listed in X3 would then be Rs. 254.80—except in the case of No. 58 A. A. Senaratne to whom at his daily rate of Rs. 8.40 there would be due an aggregate of Rs. 442.

. I also award a sum of Rs. 1050 to the Union as costs against the employers.

The above sums shall be payable to the persons and the Union to whom they are herein awarded by the Assistant Commissioner of Labour, Colombo North, on receipt of the same from the aforesaid first, Second and third employers who shall be jointly or severally responsible to pay or cause to be paid the said sums of money to the said Assistant Commissioner of Labour, Colombo North, on or before the Thirty-first day of October, 1970.

THE REPORT OF THE AUDITOR-GENERAL ON THE ACCOUNTS OF THE BUDDHA SRAVAKA DHARMAPITAYA FOR THE YEAR ENDED SEPTEMBER 30, 1969

(the figures in this report have been rounded off to the nearest rupee)

THE audit of the accounts of the Buddha Sravaka Dharmapitaya for the year ended September 30, 1969 was carried out under my direction in pursuance of Section 29 of the Buddha Sravaka Dharmapitaya Act, No. 16 of 1968.

2. The statement of accounts comprising a Balance Sheet as at September 30, 1969 and an Income and Expenditure Account for the year ended September 30 1969 were received in audit on Januray 27, 1970 but on account of errors pointed out in audit an amended set of accounts was rendered to audit on May 8, 1970.

I have to state that I have obtained all information and explanations required by me and that subject to the comments below, the Balance Sheet as at September 30, 1969 and the Income and Expenditure Account for the year then ended have been properly drawn up so as to exhibit a true and fair view of the state of affairs of the Dharmapitaya as at September 30, 1969 and the results of the financial operations for the year ended on that date.

of the financial operations for the year ended on that date.

3. Outcome of Accounts.—The income brought to account during the year comprised exclusively the Government Grant of Rs 600,000. Recurrent expenditure during the year amounted to Rs. 211,635, resulting in an excess of income over expenditure amounting to Rs. 388,365 which stood to the credit of the University Fund as at the end of the year.

Income and Expenditure Account

4. Allowance to the Chairman of Dayaka Mandalaya—Rs. 6,750.—This is the amount paid to the Chairman of the Dayaka Mandalaya at the rate of Rs. 750 per mensem from January 1969 to September 1969. Although there was no legal provision in the Dharmapithaya Act for the payment of this allowance it was made on the authority of the Cabinet pending the enactment of the necessary amendments to the Act. These amendments have however not been made up to the date of this report.

The Treasury in fixing the allowance at Rs. 750 per mensem had stipulated that the Chairman should be stationed at Anuradhapura and render full time service to the University. Even though the University started functioning only in June 1969 this allowance has been paid to the Chairman from January 1969. In May 1970 I have inquired of the Secretary whether the conditions laid down by The Treasury had been fulfilled throughout the period for which payment was made.

5. Maintenance of Buildings—Rs. 100,971.—Included in this figure was a sum of Rs. 100,527 said to be the amount payable to the School Works Engineer, Ministry of Education, for certain improvements carried out to the buildings in which the Dharmapitaya is housed at present. The correctness of this amount could not be verified in audit as the final hills for this amount were not made available for examination.

Besides the sum of Rs. 100,527 referred to above further expenditure totalling Rs. 418,561 incurred during the year under review and Rs. 24,814 incurred during the preceding year on renovating these buildings was met from the votes of the Ministry of Education and Cultural Affairs. These sums have not been incorporated in accounts of the University. I have inquired of the Secretary the basis on which only a part of the expenditure was incorporated in the accounts of the University.

The land and buildings on which the University is housed remain the property of the Anuradhapura Preservation Board and have not been vested in the University.

- (i) The improvements to the buildings were effected by the Ministry of Education under the Ministry votes of 1968-69 Liabilities amounting to Rs. 100,527 have been carried over to 1969-70 for which no provision has been made in the Ministry votes of 1969-70. The amount has to be paid out of the Dharmapithaya Grant. The Final bills for the amount has not yet been furnished to the Dharmapitaya. The payment will be sottled only on receipt of the bills.

Thus the last date specified for the receipt of notices for publication in the *Gazette* also varies depending on the incidence of public holidays in the week concerned.

Such notices will be returned to the sender by post for necessary amendment and return if publication is desired in a subsequent issue of the Gazette.
