ORDER

The Order published in *Gazette Extraordinary* No. 14,912/8 of July 2, 1970, relating to the constitution of Alawwa Town Council is hereby amended as follows :

- (1) in the First Schedule thereto, by the substitution for the description of the northern limit of the town, of the description set out in the Schedule hereto ; and
- (2) in the Second Schedule thereto, by the substitution for the figure "2/3" in the description of the northern limit of Ward No. 2 of the Figure "1/3".

SCHEDULE

"North : By a line drawn eastwards from a point 200 yards due North from the centre of culvert No. 8/5 on Alawwa-Giriulla road parallel to and at a distance of 200 yards from the centre line of the said road till it meets a point 200 yards west from the centre line of Alawwa-Dampelessa road ; thence northwards along a line parallel to and at a distance of 200 yards from the centre line of Alawwa-Dampelessa road, till it meets the common village boundary between Alawwa-Hapugahagedera (F.V.P. 462), thence eastwards along the said village boundary crossing Alawwa-Dampelessa road at the centre of culvert No. 2/2 on that road to a point 200 yards east of the centre of the said culvert No. 2/2 on Alawwa-Dampelessa road ; thence southwards along a line parallel to and at a distance of 200 yards from the centre line of Alawwa-Dampelessa road to a point 200 yards northeast from the centre line of Alawwa-Giriulla road ; thence south-eastwards along a line parallel to and at a distance of 200 yards from the centre line of Alawwa-Giriulla road to a point 200 yards north-west from the centre line of the Colombo-Kandy main line railway track ; thence north-eastwards along a line parallel to and at a distance of 200 yards from the centre of the centre line of said railway track till it meets the common village boundary between Alawwa and Koholana (F.V.P. 431) ; thence south-eastwards along the said village boundary till it meets the centre line of Colombo-Kandy main line railway track ; thence north-eastwards along the centre line of the Colombo-Kandy main line railway track to a point due north from the centre of culvert No. 44/5 on Colombo-Kurunegala Road."
