### THE VILLAGE COUNCILS ORDINANCE

Order under Section 54

BY virtue of the powers vested in me by section 54 of the Village Councils Ordinance (Chapter 257), I, Felix Reginald Dias Bandaranaike, Minister of Public Administration, Local Government and Home Affairs, being satisfied that there is sufficient proof of-(a) incompetence and mismanagement, and

(b) abuse of the powers conferred by the aforesaid Ordinance,

on the part of the Village Council of the Maho village area in the Kurunegala District, do by this Order-

(a) dissolve the Maho Village Council; and
(b) direct the Assistant Commissioner of Local Government, Kurunegala, to administer the affairs of that village area until a fresh Village Council is elected for that village area and such Village Council elects its Chairman.
