- 2. Employment in the service of any undertaking in which less than five persons are employed and which is established for the purpose of carrying on, wholly or partly, the business of civil engineering or mechanical engineering or electrical engineering. engineering.
- 3. Employment in the service of any undertaking in which less than five persons are employed and which is established for the purpose of carrying on, wholly or partly, the business of manufacturing coconut products, that is to say, the manufacture of desiccated coconut, copra, coconut oil or fibre and other
- 4. Employment in the service of any undertaking in which less than five persons are employed and which is established for the purpose of carrying on, wholly or partly, the business of exporting coir, coir mattress fibre and coir bristle fibre, that is to say, the receipt of coir fibre or bristle fibre at the stores, the process of conditioning and packing coir mattress fibre or coir bristle fibre for export and the transport of coir mattress fibre or coir bristle fibre for shipping.

The Honourable Minister of Labour, by his order dated 14th August, 1970, made under section 4 (1) of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon (1956 Revised Edition), as amended by Acts Nos. 14 and 62 of 1957, 4 of 1962 and 39 of 1968 (read with Industrial Disputes (Special Provisions) Act, No. 37 of 1968), has referred to me the following industrial dispute between the above mentioned parties for settlement by arbitration:—

"Whether the order of the management of Ceylon Tobacco Co. Ltd., placing Miss S. C. Perera on compulsory leave from 14th May, 1970, is justified and to what relief she is entitled."

When this matter came up before me on 16.11.70, Mr. N. Satyendra, instructed by Messrs Julius Creasy, appeared for the Ceylon Tobacco Co. Ltd.; and Mr. L. Athulathmudali, instructed by Messrs De Silva & Gurusinghe, appeared for Miss S. C. Perera.

Mr. Satyendra submitted that, in view of certain circumstances obtaining now, the Employer is withdrawing the order of compulsory leave served on Miss S. C. Perera, and will permit Miss S. C. Perera to resume work without prejudice to whatever action the Employer may decide to take in respect of the matters that have arisen in regard to Miss S. C. Perera's service with the Company.

Mr. Athulathmudali, on the other hand, submitted that the withdrawal of this order can only resolve this dispute on the basis that the order was unjustified at the time it was made, and that on that basis Miss Perera was prepared to resume work without prejudice to her future rights.

It appears to me that the Employer feels that at the time they sent Miss S. C. Perera on compulsory leave they may or may not have had sufficient reasons to do so. Miss Perera has been paid her salary quite regularly up-to date. Mr. Satyendra has submitted that the Company is withdrawing the order of compulsory leave without prejudice to whatever action they might take against Miss Perera; he does not want to commit himself to a situation as to whether the order of compulsory leave is justified or otherwise. I too feel that it may perhaps be premature to say anything in view of any further action they may propose to take. As the Employer is prepared to take back Miss S. C. Perera and give her work, it is unnecessary to discuss the complications that might arise at a leter stage; it might prejudice both parties.

Miss S. C. Perera will be free to resume work on the 22nd November, 1970, as the Company has withdrawn the order for compulsory leave. The Employer shall also pay Miss S. C. Perera, a sum of Rs. 250 as costs of action; payment to be made within one month of this Award.

This is an Award under section 17 of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon (1956 Revised Edition), as amended by Acts Nos. 14, 62 of 1957 and 4 of 1962 and 39 of 1968 (read with Industrial Disputes (Special Provisions) Act, No. 37 of 1968).

- 2. The Hon'ble Minister of Labour and Employment, by his Order dated 2nd December, 1969, made under section 4 (1) of the aforesaid Act, referred the above mentioned dispute to me for settlement by arbitration.
- 3. The matter in dispute between Mr. M. G. D. Jayaratne and the Ceylon Transport Board, is "Whether the Ceylon Transport was justified in not promoting Mr. M. G. D. Jayaratne to (the then) Grade IV of the Board's service in and after 1960 and if not, to what relief Mr. Jayaratne is entitled."
- 4. Mr. W. E. M. Abeysekera, Advocate, instructed by Mr. A. M. Banduratne appeared for Mr. M. G. D. Jayaratne and Mr. S. Sunderalingam, Assistant Legal Officer, appeared for the Ceylon Transport Board.
- the Ceylon Transport Board.

 5. Mr. Jayaratne was an employee of the Eastern Bus Company in Batticaloa on a salary of Rs. 100 and was taken into the service of the C. T. B. (Ceylon Transport Board) on 1.1.1958 and was known as a section 38 employee. In January 1959, he was a Class IV clerk drawing a salary of Rs. 170 and was promoted to Class III of the Board's Clerical Service on 1.7.59 on a salary of Rs. 183. From Class III he was appointed to the then Grade V of the Board's Service and from a remunerative standpoint this appointment was less favourable than if he had remained in the clerical service—vide A. 4. He presented himself for a written examination on 14.11.59 for the then Grade IV. The marks list of that Examination was not produced as it had been destroyed. I find it difficult to believe that he became aware of the fact that he scored 73, 76 and 79 marks on a cursory glance of the papers at the interview. He was in Grade V on 1.8.60 on a salary of Rs. 187/50 on the recommendation of the Chief Operations Manager in accordance with Circular dated 14.7.60 marked A.3 which states that "Class III Officers may be appointed on the salary they draw now with no change in their present dates of increments". He obtained the required aggregate marks and was called for interview, but was unsuccessful at the interview.
- 6. In 1962 he sat again for the Examination and was interviewed on 4.7.63, but was not called for the second interview. Vide A 6 B. In 1962 and 1963 he earned two commendations for working during strikes. Mr. Weerasekera, the Deputy Personnel Manager, who was also a member of the Interview Board on 4.7.63 stated that from the date of the applicant's appointment there had been nothing in the Depot files or in the Head Office files against him, and he had earned his annual increments regularly. The 1962 Examination marks list was not produced as it had been destroyed. The confidential report on Mr. M. G. D. Jayaratne marked A. 7 which was signed by the then Regional Manager, Mr. Piyadasa, came in for heavy criticism by Counsel for the employee on the ground that it had not been properly filled. A. 7 has to be completed by the Regional Manager in consultation with the Depot Manager or as officer not below the rank of Grade II in consultation with the Staff Assistant/Head of Branch, where necessary. Columns 9—26, except 11, have been filled by the Assistant Regional Manager and signed by Mr. Piyadasa the then Regional Manager. Mr. Piyadasa stated in his evidence that he need not fill every column provided his Assistant could do it. The proper procedure would have been for Mr. Piyadasa to have consulted his Assistant before he signed A.7. It was unfortunate that he had not done so. He also admitted that if particulars given by his Assistant were incorrect he had put his signature to an incorrect statement. A 7 has undoubtedly been completed without due carc. and I would like to emphasise that confidential reports, which are of great importance in the matter of promotions, should be completed with great care and attention. However, A.7 would not have belped the applicant as he was not called for the second interview—and it would appear that it was at the second interview been considered at the first interview on 4.7.68 by the Interview Board.
- 7. He sat for the 1965 Examination but was unsuccessful in the written Examination—vide R.17. Although there was no interview it is surprising that the then Personnel Manager, Mr. Wanigasekera, had misrepresented facts to the Minister for Nationalised Services that there was an interview. The 1965 Examination marks list was available and 18 appear to have nassed the Examination and 16 were promoted—vide A 12. No evidence has been adduced that members of the respective interview boards were actuated by ill-will or improper motives towards Mr. Javaratne. According to A 8 dated 30th May 1966, the Head of the Division should maintain a register of documents destroyed but this register was not produced. Answer Scripts of promotion and recruitment tests should be destroyed only after a period of two years. It is regrettable that instructions issued to the Head of Division had not been carried out. What instructions were in force prior to A 8 is not known.

- 8. It is in evidence that certain employees have been promo-8. It is in evidence that certain employees have been promoted to the old Grade IV without either having sat for the Examination or having been called for the interview. D. C. Wijeratne was promoted to old Grade IV in 1964 without having sat for the Examination and his name does not appear in A.2 or A.3. P. H. Wimalasena failed the 1962 Examination but was promoted to Grade IV without having been called for an interview. Ananda Weeraratne failed the 1962 Examination but was promoted without having been called for an interview. T. S. M. Abeysekera had been promoted in 1965, although disciplinary action was taken against him, but was rated T. S. M. Abeysekera had been promoted in 1965, although disciplinary action was taken against him, but was rated "excellent"—A 12. A. S. Weeraratne was credited with one Wimalasena's marks in the Interview Schedule and was interviewed and promoted to Grade IV. It is in evidence that political interferences and favouritism in the matter of appointments and promotions are rampant in the C. T. B. Mr. Weerasekera admitted that there had been criticism in regard to appointments admitted that there had been criticism in regard to appointments and promotions in certain newspapers. This pernicious practice of making haphazard promotions should be condemned and I would draw the attention of the authorities concerned thereto.
- 9. In 1966 merit promotions were given by the Board to 'Section 38' employees, but the employee in the instant case, was not given a merit promotion. It is in evidence that certain employees who joined the C. T. B. after Mr. Jayaratne got their merit promotions. B. H. Wickremasinghe and Leslie Thabrew, who were not 'section 38' employees, were given merit promotions. Mr. Weensekera has stated that he is unable to say whether B. H. Wickremasinghe, who was given a merit promotion, was a 'section 38' employee. Also, certain Trolley bus Service employees were taken into Grade IV in 1960 without having sat for any examination. It would appear that there is no consistent policy in the matter of such promotions and appointments. Merit promotions were made on confidential reports, In the confidential report of Mr. M. G. D. Jayaratne A.13 he was characterised as 'Good' and recommended for promotion. He had been commended for attending office during all C. T. B. strikes. Mr. Dharmawardena, the then Regional Manager, who signed A.13 had not been called by the Board. The inference one can draw is that, had he been called, he would have testified in favour of Mr. Jayaratne. Mr. Jayaratne pa sed the Examination on 3.9.67, and was promoted to (New) Grade VIII on 1.10.67. At an interview on 2.8.69. He was promoted to (New) Grade VI (which was the old Grade IV) from 20.3.70. Mr. Fernando, Chief Operations Manager, and Mr. Wijemanne, Traffic Manager, have both stated in evidence that increments would not have been given if the employee's confidential report at the time the increment was granted was considered unsatisfactory and that increments are not given automatically. Mr. Jayaratne has earned his annual increments regularly. regularly.
- 10. Having considered all the evidence and the documents placed before me, I am of the opinion that Mr. Jayaratne should have been given a merit promotion in 1966. I accordingly hold that Mr. M. G. D. Jayaratne be promoted to the (then) Grade IV of the Board's Service from the date on which merit promotions were given in 1966 on the salary scale he would have been entitled to had he been promoted at that time. I also hold that he be given his annual increments and the arrears of salary and all other benefits accruing therefrom. All such payments to be made within one month of the publication of the Award in the Government Gazette.

I make Award accordingly.
