THE ASSIGNMENT OF MINISTERS' FUNCTIONS (CONSEQUENTIAL PROVISIONS) ACT

Order under section 2

WHEREAS the subject of "Pensions" formerly assigned to the Minister of Finance has now been assigned to the Minister of Public Administration, Local Government and Home Affairs by the Prime Minister, by assignment made under section 46 (4) of the Ceylon (Constitution) Order in Council, 1946, and published in *Gazette Extraordinary* No. 14,908/6 of June 2, 1970:

And whereas it is necessary to make amendments to certain written law in consequence of such assignment:

Now, therefore, I, Sirimavo Ratwatte Dias Bandaranaike, Prime Minister, do, by virtue of the powers vested in me by section 2 of the Assignment of Ministers' Functions (Consequential Provisions) Act (Chapter 385) by this Order amend the written law specified in column I of the Schedule hereto in the manner and to the extent specified in the corresponding entries in column II of that Schedule.

Town Councils Ordinance (Chapter 256) as amended by the Local Authorities (Special Provisions) Act, No. 7 of 1959	For the words "with the approval of the Minister given after consultation with the Minister of Finance" wherever they appear in sections 172A and 172B there shall be substituted the words "with the approval of the Minister".
4. Village Councils Ordinance (Chapter 257)	For the words of "with the approval of the Minister given after consultation with the Minister of Finance" wherever they appear in sections 49A and 49B there shall be substituted the words "with the approval of the Minister".
