THE ASSIGNMENT OF MINISTERS' FUNCTIONS (CONSEQUENTIAL PROVISIONS) ACT

Order under Section 2

WHEREAS the subject of "Public Service Provident Fund" formerly assigned to the Minister of Finance has now been assigned to the Minister of Public Administration, Local Government and Home Affairs by the Prime Minister, by assignment made under section 46(4) of the Ceylon (Constitution) order in Council, 1946 and published in Gazette Extraordinary No. 14,908/6 of June 2, 1970.

And whereas it is necessary to make amendments to certain written law in consequence of such assignment.

Now, therefore, I, Sirimavo Ratwatte Dias Bandaranaike, Prime Minister, do, by virtue of the powers vested in me by section 2 of the Assignment of Ministers' Functions (Consequential Provisions) Act (Chapter 385) by this Order amend the written law specified in column I of the Schedule hereto in the manner and to the extent specified in the corresponding entries in column II of that Schedule.

SCHEDULE

Column II

- (a) For the expression "Minister of Finance" in sections 3 (2), 15, 24 (2) and 27 (1) there shall be substituted the expression "Minister of Public Administration, Local Government and Home Affairs".
- (b) For the expression "Secretary to the Treasury" wherever that expression occurs in section 26(1) and (2) there shall be substituted the expression "Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs".
- (c) For the expression "Deputy Secretary to the Treasury" in Sections 2(2), 3(1) (a), 3(3), 9, 13(2) (ii), 22, 24(1), and 25 there shall be substituted the expression "Director of Pensions".
- (d) For the expression "Deputy Secretary to the Treasury" wherever that expression occurs in section 17 there, shall be substituted the expression "Director of Pensions".
