CEYLON PETROLEUM CORPORATION

Order under sub-section (1) of section 5C of the Ceylon Petroleum Corporation Act, No, 28 of 1961 as amended by the Ceylon Petroleum Corporation (Amendment) Act, No. 5 of 1963.

WHEREAS by virtue of sub-section 1 of section 5C of the said Act the Minister of Industries and Scientific Affairs is empowered to vest exclusively in the Corporation the right to import, export, sell, supply or distribute petroleum of any class or description not being petroleum of any class or description specified in sub-section 1 of section 5B aforesaid.

I, Tikiri Banda Subasinghe, Minister of Industries and Scientific Affairs do hereby make order declaring that with effect from the 1st day of January 1971 the right to import, export, sell, supply or distribute all lubricating oils and greases other than aviation lubricating oils and greases shall vest exclusively in the Corporation.
