#### Local Government Notifications

##### THE URBAN COUNCILS ORDINANCE

Order under Section 184

BY virtue of the powers vested in me by Section 184 of Urban Councils Ordinance (Chapter 255), I, Felix Reginald Dias Bandaranaike, Minister of Public Administration, Local Government and Home Affairs, being satisfied that there is sufficient proof of—

- (a) wilful neglect and misconduct in the performance of the duties imposed by the said Ordinance,
- (b) incompetence and mismanagement, and
- (c) abuse of powers conferred by the said Ordinance on the part of the Matara Urban Council, do by this Order—
  - (a) dissolve the Matara Urban Council; and
  - (b) appoint Mr. Vithanwasam Keerthichandra Nanayakkara, Assistant Commissioner of Local Government, to be the Special Commissioner to administer the affairs of the Town Council of Matara until a new Urban Council is constituted for that town under the said Ordinance, and, for that purpose, to exercise the powers and perform the duties of an Urban Council under the said Ordinance.

##### THE URBAN COUNCILS ORDINANCE

Order under Section 184
