## **NOTICES UNDER THE WASTE LANDS ORDINANCE.**

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

**T**AKE notice, that unless within three months from the 31st day of March, 1900, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegulla Kachcheri and make claim to the said land or to some interest therein.

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

### *Description of Land received in*

Lot 475 on preliminary plan 237 called Akahekandamukalana, situated in the villages Boduwila and Wadukanda in Otara patti of Beligal korale, in the Kegalla District, containing in extent 48 acres and 11 perches, as described in the annexed plan; and bounded on the north by Boralahena and Wadukandahena; on the east by Crown forest called Hewandeni-kandamukalana, Hewadeniyahena, Crown forest called Hewandenikandamukalana, and the village boundary of Hatungoda village; on the south by Diganwelahena, a portion of the village boundary of Hatungoda village, Galugawadeniyahena, and Galagawadeniyawatta; on the west by Kahagal-oya, Medellahenawita, Tenneheni, Veraluhena (P.P. 237), Maellahena, 475; Pillamullehena, Kotugallahena, and Narangahamulahenayaya.


