[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

**T**AKE notice, that unless within three months from the 31st day of March, 1900, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachcheri and make claim to the said land or to some interest therein:


