## **NOTICES UNDER THE WASTE LANDS ORDINANCES.**

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

**T**AKE notice, that unless within three months from the 21st day of April, 1900, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachcheri and make claim to the said land or to some interest therein :

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said land to which no claim has been made is the property of the Crown.

*Description of Land referred to.*

Lot 2,089 on preliminary plan 683, called Pitiyahena *alias* Kebellagollemukalana, situated in the village Rahala in Tumpalat patty of Paranakuru korale in the Kegalla District, containing in extent 32 acres and 2 roods as described in the annexed plan; and bounded on the north by Gallanehena and irrigation channel; on the east by Rahalagama or Watanawewela and the village boundary of Rahala village; on the south by a rocky precipice and Rahalagala; on the west by dola and Kandawattahena.


