The Rules made under the Council of Legal Education Incorporation Ordinance, as last amended by notification dated September 11, 1971, and published in the "Ceylon Government Gazette" No. 14,984 dated November 12, 1971, were further amended at the meetings of the Council of Legal Education held on November 5, 1971, June 9, 1972, August 3, 1972, October 20, 1972 and December 19, 1972, as follows:—

- (a) Rule 13 by re-numbering the existing clause as (1) and by adding a new clause, "(2) The Council shall also, on the recommendation of the Board of Studies, make suitable provision for tutorial classes in specified subjects."
- (b) Rule 21 by the addition between the word "course" and the word "and" in line 2 of the following words:—
  - "and of such tutorial classes as may be prescribed."
- (c) Rule 24 by the addition of the words and figures "of Rs. 12" after the words "Societies' fee" in line 6.
- (d) Rule 26 by the addition of the words "or is referred under Rule 68" after the word "Examination" in line 16,

- (e) Rule 27 by the addition of the words "or is referred under Rule 68" after the word "Examination" in line 16.
- (f) Rule 59(1) by the deletion of all the words after the word "directs" in line 6.
- (g) Rule 59(2) by the addition of the words "and he shall not thereafter be entitled for admission under Rule 23" after the word "students" in line 3.
- (h) Rule 75(2) (c) by the substitution of "Rs. 36" for "Rs. 18" in line 14.
- (i) The addition of the subject "Legal History & Legal System" to the list of subjects prescribed for the award of Prizes in Rule 52(4) under 'Resolutions.'
- (j) By the addition of the following Forms of Certificates, alternative to Forms A and B in lieu of the prescribed form mentioned in Schedule II:—
