NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinance No. 1 of 1897 as amended by No. 1 of 1899.]

TAKE notice, that unless within three months from the 12th day of May, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

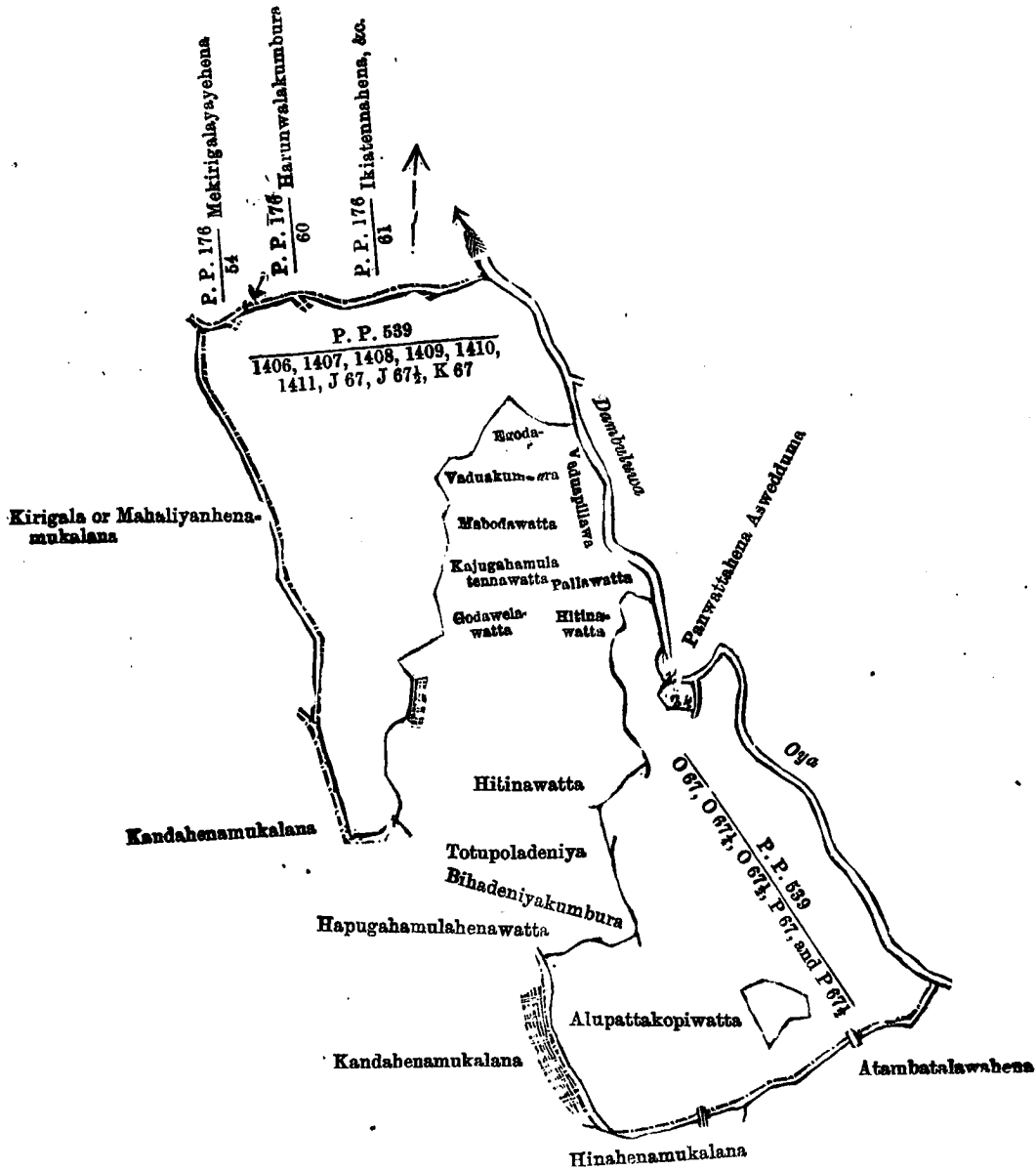
Alupallakopiawatta lying within these boundaries is excluded from the notice.
