NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 14th day of May, 1900, the persons, if any, who claim any interest in the lands hereinabove mentioned or in any one or more of such lands, appear before me at the Ratnapura Kachcheri and land court, the islands or any of them or to some interest therein:
