NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 26th day of May, 1900, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachcheri and make claim to the said land or to some interest therein:

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Description of Land referred to.

A block of land comprising lots 1,443 and 1,444 on preliminary plan 550 called Kirangalahukalana, situated in the villages Telleke and Duldeniya in Tumpalata pattu of Paranakuru borale, in the Kegalla District, both in extent 23 acres 2 roods and 32 perches, as described in the annexed plan, and bounded as follows : on the north by Ketawalahena, Galandehena, Wassadeniya ; on the east by Wassadeniya, land appearing on title plan 54,983 called Dahasahala, land appearing on title plan 54,988 called Kongahadepale, land appearing on title plan 55,022 called Singuneduwe, land appearing on title plan 175,688 called Ganwadipilakumbura, land appearing on title plan 54,982 called Udakumbura and Deniyakumbura ; on the south by Udalwalpolahena, Galkotuwehena, Dunumadalagahahena, Makewitahena, Kosgollehena, and the village boundary of Bowalgaha village ; on the west by Kirangalahena-ela, Kirangalahena, Welikumburahena, Ketawelahena, Polgollehena, Mala-ela.


