NOTICES UNDER THE WASTE LANDS ORDINANCES

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 26th day of May, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein:

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The following lots, situated at the village Mainnoluwa in Kiraweli patta of Beligalkorale, in the Kegalla District, as described in the annexed plan :-

1. Lots 1,253 and 1,254 on preliminary plan 490 called Verellemukalana, both in extent 7 acres 1 rood and 17 perches ; and bounded on the north by the temple land appearing on title plan 101,438 of Dorawaka Nata Dewale and the village boundary of Dorawaka ; on the east by Ambagastenne and Burugalahena ; on the south by Ange-ela and Angekumbura and Munamalsahamulahena ; on the west by Tennarishene.

2. Lot 1,249 on preliminary plan 483 called Pelawattamukalana, in extent 4 acres 2 roods and 34 perches; and bounded on the north by Dodangahamakadhen, Walbeligahamulahena, and Udawattahena; on the east by Laulugahamulahena and Galahena; on the south by Hittinawatta; on the west by Puhawahahena.


