#### TRAFFIC CONTROL NOTICE

## Poson Festival—1973—13.6.73 to 18.6.73 Anuradhampura and Mihintale

IT is hereby notified that during the above mentioned period a 'One Waw' Traffic Scheme will be operated within the Sacred City of Anuradhapura and at Mihintale, whereby the flow of traffic and parking of vehicles will be subjected to control.

- 2. Traffic entering the Sacred City at Anuradhapura will be diverted by Police as follows:—
  - (a) All traffic coming along Puttalam Road will be diverted at Tissawewa Rest House left to proceed to Sacred City Area and right to New Town and Kurunegala Road.
  - (b) All traffic coming along Kurunegala Road will be turned left towards Puttalam Road and Sacred City area and right to the New Town. Traffic will NOT be permitted to proceed straight towards the Sri Maha Bodhi.
  - (c) All traffic coming along Jaffna Road will be turned left towards Mihintale and New Town and will NOT be permitted to turn right at Jaffna Junction.
  - (d) All traffic coming from Mihintale will be turned left to the New Town near the Jaffna Junction Level Crossing.
    Only those vehicles proceeding towards Jaffna will be permitted to proceed to Jaffna Junction.
- 3. The railway gate on Sri Maha Bodhi Road will be closed for vehicular traffic during the above period, viz: 13.6.73 to 18.6.73.

#### 4. Mihintale:

All traffic from Anuradhapura to Mihintale will be diverted along Niwaththaka Chettiya Road to Jaffna Junction and Mihintale.

- 5. Only C.T.B. Buses with 'Yellow' labels and private cars will be permitted to proceed to the foot of the Mihintale Hill. All other traffic will be parked in the special parks constructed by the side of the Gaikulama Road. Lorries, however, which carry food and re-freshments for the 'Dansalas' will be permitted to go to the foot of the hill. These vehicles will be provided with 'passes' for the purpose of carrying food.
- 6. All traffic except C.T.B. buses will return from Mihintale via Galkulama Junction and Airport Road or Galkulama/Matale Road Junction and into town. This 'One Way' traffic scheme will come into operation from the 13th morning. O.I.C. Mihintale Post will use his discretion and permit vehicles proceeding to Trincomalee, Horowpothana and Galenbindunuweas to use the By-pass Road behind the Mihintale Post Office and then turn right towards Trincomalee.

#### 7. General:

Vehicles coming from Kandy will be diverted to left from the Galkulama Junction to proceed to Jaffna, Anuradhapura, Mihintale and Trincomalee,

8. No traffic will be permitted to proceed from Galkulama Junction towards Mihintale.
