NOTICE is hereby given that the Government Agent, Kandy District, (hereinafter referred to as the Government Agent, which expression shall include any officer duly authorised for the purpose of this sale by the said Govt. 5. The Government Agent may before accepting any bid satisfy himself of the bona fides of the person making the bid and his capacity and financial ability to comply with the conditions of the lease. If he is not so satisfied, the Government Agent may refuse to accept such bid and continue the sale as if no such bid had been made.

6. Every bidder shall be present in person, or by a duly accredited agent, at the aforesaid place and time. Accredited agents must produce their letters of appointment for scrutiny by the Government Agent prior to the sale.

7. Every successful bidder shall immediately after his bid is accepted pay to the Government Agent one-tenth of the amount of his bid and the first year's rent in advance, and the balance amount of his bid within one month of the date of sale. In the event of the bidder failing to pay any of these sums within the prescribed time the Government Agent may cancel the sale and confiscate any monies paid by such bidder. If the lease of that land is subsequently offered for resale, no bids will be accepted from such bidder.

8. On due payment of the sums specified in condition 7 above, the successful bidder shall be entitled to be placed the possession of the block purchased by him and to receive an Indenture of lease for that block. The successful bidder shall execute the indenture of lease within 14 days of its being presented to him. In the event of his failing to do so, the Government Agent shall be entitled to cancel the sale and confiscate any monies paid by such bidder.
