The Soldiers Service Regulations, 1950, published in Gazette No. 10,085 of March 17, 1950, as amended from time to time, are hereby further amended as follows:—

- (1) by the substitution for regulation 3 thereof, of the following new regulation-
 - "3. A soldier may, before the expiry of the period of his original enlistment, be re-engaged for further service in the Regular Force. Such further service may

be in one or more periods, but the aggregate period of such service shall not exceed twenty years:

Provided, however, that no soldier shall serve beyond the age of 55 years; "

- (2) in regulation 9, by the substitution, in paragraph (1) thereof, for the words "the Permanent Secretary in consultation with the Commissioner of the Army", of the words "the Commander of the Army";
- (3) in regulation 11 thereof, by the substitution for the words "the Permanent Secretary", of the words "the Commander of the Army ";
- (4) in regulation 15 thereof, by the substitution for the words "in the tenth year of the period of his re-engagement", of the words "in the tenth year of his re-engaged service", and
- (5) in regulation 17 thereof, by the substitution for the words "in the tenth year of his period of re-engagement", of the words "in the tenth year of his re-engaged service".

REGULATION made by the Minister of Defence and Foreign Affairs, under section 161 of the Navy Act (Chapter 358), as amended by Act No. 11 of 1962.

The seamen's Enlistment and Service Regulations, 1950, published in *Gazette* No. 10,187 of December 9, 1950, as amended from time to time, are hereby further amended as

- (1) by the substitution, for regulations 7, 8, 9, 10, 11 and 12 thereof, of the following new regulations respec-
 - " (7) (a) The period of original enlistment of a seaman, who is or has been enlisted prior to the date of publica-tion of this regulation in the Gazette, shall be twelve years and he shall serve such period in the Regular Naval Force.
 - (b) The period of original enlistment of a seaman, who is or shall be enlisted after the date of publication
 - (i) if he is enlisted in any of the Artificer Branches of the Navy, his period of original enlistment shall be twelve years and he shall serve such period in the Regular Naval Force.
 - (ii) if he is enlisted in any branch other than one of the Artificer Branches, his period of original en-

listment shall be twelve years of which he shall serve the first five years in the Regular Naval Force and the remaining seven years in the Regular Naval Force and the remaining seven years in the Regular Naval Reserve unless otherwise ordered by the Captain of the Navy. Before the expiry of the period of five years referred to above, he may, if his retention in the Regular Naval Force is considered necessary be allowed to extend his service in the Regular Naval Force for a period not exceeding seven years. not exceeding seven years.

- 8. (i) A seaman may before the expiry of the period of his original enlistment be re-engaged for service in the Regular Naval Force for one or more periods not exceeding twenty years.
- (ii) any seaman who is re-engaged under regulation 8 (1) shall, in the first instance serve for a period not exceeding ten years, and he may upon the expiry of that period be re-engaged to serve a further period or periods not exceeding an aggregate of twenty years of re-engaged service, so however, that his total period of service shall not exceed thirty-two years from the date of his original enlistment. date of his original enlistment.

- (b) Any seaman who is not re-engaged beyond the period of original enlistment or of re-engagement may be transferred to the Regular Naval Reserve for service for a period of five years.
- 12. A seaman whose service is not extended or who is not re-engaged beyond the period of original enlistment or of re-engagement or who is not transferred to the Regular Naval Reserve shall be discharged from the Nava." the Navy ''.
