As a result of the death of the workman, Counsel for the employers submitted that this Tribunal has no jurisdiction to make an award whereas the Counsel for the applicant made his submissions and stated that the Tribunal should make an award in view of the fact that all evidence has been placed before this Tribunal. Further written submissions have been made by both sides.

I have considered whether this Tribunal can make an award after the death of the workman. As the reference by the Minister is to settle the dispute by arbitration between the two parties, I am of opinion that no dispute exists now after the death of the workman and as such I do not make an award in this regard. However, in view of the tragic circumstances under which the workman is said to have died, I recommend that the employers shall take into consideration the services rendered by the workman and grant edequate relief to the dependents of the workman and grant adequate relief to the dependants of the workman.

#### Award

The Honourable Minister of Labour by virtue of the powers vested in him by section 4 (1) of the Industrial Disputes Act, Chapter 131 of the legislative enactments of Ceylon (1956 revised edition) as amended by Acts Nos. 14 of 1957, 62 of 1957, 61 of 1962 and 39 of 1968 (read with Industrial Disputes (special provisions) Act No. 37 of 1968) appointed me to be the Arbitrator and referred the dispute to me for settlement by arbitration.

The matter in dispute between the parties is whether the termination of the services of 30 employees who are members of the Union by the Management of Electro Plastics Limited is justified and to what relief is each of them entitled.

Considerable evidence was led by the Union to show that the termination of the services of the employees was not justified. According to the Union on or about the 20th August, 1970, the Union organised a strike and on or about the 29th of August, the employer served retrenchment notice on 112 of its employees and terminated the services of 51 employees including the 30 workmen under reference.

However representatives of the Union as well as the Employer participated in several conferences convened by the Labour Department with a view to settling the strike and on the 31st October, 1970, at a conference presided over by the Deputy Commissoiner of Labour a settlement was reached and the Union called off the strike and instructed its members to report for work. However the employer refused to offer work to the 30 employees under reference. The Union in their statement asked for the reinstatement of these 30 employees. The management stated that they were unable to take these workmen as there was no work to offer and they did not have the Financial Capacity to pay them "unless production increases a great deal more". They however stated that in any event the work and conduct of the members of the Union did not justify their being re-employed. "Indeed great loss and damage and disruption of work has been caused earlier by the members of the Union and

indiscipline encouraged." On the 8th of February, 1973, Mrs. Wettasinghe representing the Management was present in Court with her Counsel and assumed responsibility of settling the dispute. It was agreed between the Management and the Union representative of the employees, that each of the following employees will receive compensation of Rs. 750 in full settlement. It was however agreed between the Management and the Union that the other 15 employees under reference will not be entitled to any remedy what so ever that the Union withdraws the application in respect of them, in view of the Management compensating the following 15 employees mentioned below:—
