## Trade Mark Notices

### Hours of Inspection

The office shall be open to the public for inspection of the register on every working day from nine a.m. to three p.m. and on every half day from nine a.m. to eleven a.m. Applications for inspection of the register will, however, be accepted up to 2 p.m. on working days and 11 a.m. on half days.

# Trade Marks limited to Colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to

certain colours, the colours are, as far as possible, indicates in the accompanying representation of the mark in thusual heraldic manner.

### Association

Where it is stated that an advertised mark is to be associated under Section 22 of the Trade Marks Ordinance (Cap. 121) with another mark, it is indicated by its official number.

## **OPPOSITION**

NOTICE is hereby given that any person who has ground of objection to the registration of the following Trade Mark may, within two months from the date of this *Gazette*, lodge Notice of Opposition on from T.M. No. 7 bearing an uncancelled or impressed stamp of Rs. 25. The period of lodging Notice of Opposition may be enlarged by the Registrar if he thinks fit and upon such terms as he may direct.
