Resolution

"This Assembly resolves, under the provisions of section 3 (b) of the Housing and Town Improvement Ordinance (Chapter 268), that, from 1st May, 1973 the aforesaid Ordinance shall be in force within the area defined in the Schedule hereto."

SCHEDULE

Dambadeniya

All that part of the area situated in the Village of Puskeladeniya, Aturuwala, Udiyawala, Riligala and Dambadeniya in Udukaha Korale West of Dambadeni Hathpathu in Kurunegala District, North-Western Province, and bounded as follows:—

North: From a point 175 yards west of centre line of Narammala-Giriulla P.W.D. Road and 100 feet north of the centre line Dambadeniya-Bihapola P.W.D. Road, by a line drawn South Eastwards upto a distance of 350 yards.

East: From the last mentioned point by a line drawn 175 yards East of and parallel to the centre line of the said Narammala-Giriulla P.W.D. Road, Southwards till it meets a line drawn parallel to and 150 yards north of centre line of Alawwa-Maharagama P.W.D. road, thence eastwards by the continuation of the same line parallel to and at a distance of 150 yards, till it meets a line drawn perpendicular to the centre line of the said Alawwa-Maharagama P.W.D. Road at the centre of the culvert No. 1/2, thence southwards by the continuation of the same line upto a distance of 300 yards.

South: From the last mentioned point, by a line drawn 150 yards south of and parallel to the centre line of the said Alawwa-Maharagama P.W.D. road, Westwards till it meets the western boundary of Puskeladeniya village (western boundary of Dambadeniya Village Council).

West: From the last mentioned point by a line drawn along the said village boundary northwards, upto a point at which it meets the line drawn parallel to and at a distance of 175 yards west of the centre line of the said Narammala-Giriulla P.W.D. road, thence northwards parallel to and at a distance of 175 yards till it meets the starting point of the northern boundary.

For the purpose of the By-law 1 of the By-laws relating to markets and bazaars, made by the Village Council of the Ambagamuwa South village area in the Kandy District, the “Market area” in respect of the Maskeliya market shall be the area within the following boundaries which has been declared as the villages where Maskeliya Town buildings have been constructed.

North by a line drawn eastwards, north-eastwards, northwards, north-eastwards and eastwards from a line at the point where it intersects the centre lines of Maskeliya-Maussakele South Bank Road and Brownlow Estate Road and situated perpendicularly 15 chains north to the centre of Maskeliya-Maussakele South Bank Road till it meets a point on the centre line of the said stream parallel to and at a distance of 15 chains from the centre line of Maskeliya-Maussakele South Bank Road and at the intersection of the centre line of the said road and the said stream over which the new bridge 41'-0" is built thence north-eastwards along an imaginary line till it meets the centre line of Maskeliya-Hatton P.W.D. road near the 11th mile post, thence eastwards to a point at a distance of 15 chains on a perpendicular line drawn up to the centre line of the said P.W.D. road.

East by a line drawn from the last-mentioned point south-eastwards along an imaginary line the centre of the junction where the estate road meets the path leading to Glentil Group near Sheds Nos. 155 and 156 respectively known as Tea Collecting Centre and Estate Boutique, thence south-eastwards along an imaginary line to the centre of the junction where Maskeliya Estate Road and the road leading to Maskeliya Tea Estate Factory meet together and thence south-eastwards along an imaginary line to the centre line of the said road near the 1st mile post on Maskeliya-Samimale P.W.D. road.

South by a line drawn from the last-mentioned point north-westwards along the centre line of Maskeliya-Samimale P.W.D. Road till it meets southern entrance of the new bridge 90'-0" across Maskeliya Oya, thence westwards and southwards along Maskeliya Oya and upon

water level of Maskeliya Tank aid by extension of the perpendicular line across the Tank and up to the south bank to the centre line at the point where the centre lines of Maskeliya-Maussakele Road and Brownlow Estate Road intersect.

West by a line drawn from the last-mentioned point northwards along the extension of the perpendicular line drawn southwards across the Maskeliya Tank to its southern bank and to the centre line of Maskeliya-Maussakele South Bank road at the point where it intersects the centre line of Maskeliya-Maussakele southern bank and to the centre line of Maskeliya-point where it intersects the centre line of the said road, thence northwards along the said perpendicular line till it meets the starting point of the southern limit of the ward.

BY-LAW RELATING TO THE PUBLIC MARKET AND FAIR

1.
