The Learned Commissioner of Labour by virtue of the powers vested in him by section 3/1 (d) of the Industrial Dispute Act, Chapter 131, as amended by Industrial Disputes (Amendment) Acts, Nos. 14 and 62 of 1957, 4 of 1962, and 39 of 1968 (read with Industrial Disputes (Special Provisions) Act, No. 37 of 1968), appointed me as arbitrator and referred the dispute to me for settlement by arbitration.

The parties to the dispute had consented to the reference of the dispute for settlement by arbitration and have jointly nominated me as arbitrator.

The matter in dispute between the parties is whether the termination of the services of Mr. T. M. A. Packeer by Messrs. Hunter & Company Limited is justified and to what relief if any is Mr. T. M. A. Packeer entitled.

At the inquiry Mr. S. R. de Silva, Deputy Secretary, Employer's Federation of Ceylon, appeared on behalf of Messrs. Hunter & Company Limited, Mr. Prins Rajasuriya instructed by Mr. R. H. Bhagawan appeared for the Ceylon Mercantile Union.

According to the employer's statement of the matter in dispute Mr. Packeer joined the services of the Company on 14th May, 1960, and at the time that his services were terminated was a

clerk in the Accounts Department of the Company. At the time of termination Mr. Packeer was in receipt of a monthly salary of Rupees Four Hundred and Twenty Two and Cents Fifty (Rs. 422.50). At the time that his services were terminated Mr. Packeer's duties consisted of submission of monthly sales analysis statements, the submission of representatives sales figures, passing of local invoices and cheque payment bills. He was required by a letter of 5th September, 1972, to show-cause why disciplinary action should not be taken against him in respect of the matter set out in the letter. Mr. Packeer's explanation was unsatisfactory, an inquiry was held and thereafter his increment was stopped for a period of twelve (12) months as a punishment in terms of a letter dated 28th September, 1972. Since there was a delay in the submission of the sales analysis statement the Company addressed a further communication to Mr. Packeer dated 29th September, 1972. Mr. Packeer replied and the Company addressed another show-cause letter to him on the 18th of October, 1972.

Since Mr. Packeer's explanation was unsatisfactory an inquiry was held and on the evidence led at the inquiry his services were terminated with immediate effect by letter dated 27th November, 1972. It was submitted by the employer that the termination of Mr. Packeer's services was bona fide and perfectly justified in the circumstances and that he was not entitled to any relief what-so-ever.

The Union however submitted that the discontinuance of Mr. Packeer was unjustified and requested that he be re-instated.

From the commencement of the inquiry parties and Counsel made an all-out effort to settle the dispute. They discussed various avenues to a satisfactory settlement of the dispute and finally I am glad to be able to say that on the 13th of July, 1973, they assumed the responsibility of settling the dispute and the terms of settlement were duly signed by the parties.

The dispute was settled on the following terms.

- (1) The Company agrees to re-employ Mr. Packeer with effect from 16th July, 1973.
- (2) Mr. Packeer's re-employment will be without a break in service but he will not be entitled to any back wages.
- (3) Mr. Packeer agrees to submit to the Company the monthly sales analysis statement by the 7th of the following month. The Company agrees wherever possible, to render such assistance as is reasonable in the circumstances, in those instances when Mr. Packeer is on long leave. Such assistance will be limited to helping him in the clearing up, as far as possible, of arrears of work which arise during the period of such long leave.
- (4) It is also agreed that this settlement does not in any way vary or alter Mr. Packeer's duties or functions or obligations as an employee of the Company.
