THE following resolution passed by the Kolonnawa Urban Council under sub-section (1) of section 2 of the Entertainment Tax Ordinance (Chapter 267), has been approved by the Minister of Public Administration, Local Government and Home Affairs and is published in terms of sub-section (2) of that section.

##### RESOLUTION

"This Council under sub-section (1) of section 2 of the Entertainment Tax Ordinance (Chapter 267), hereby imposes and levies, with effect from the date on which this resolution is published in the *Gazette*, a tax at the rates set out hereunder on payments for admission to entertainments (as defined in the Ordinance), held in the area within the administrative limits of the Council in lieu of the tax imposed and levied in respect of such payments by resolution published in *Gazette* No. 10,344 of January 18, 1972.
