RULES made by the Public Service Mutual Provident Association under section 16 of the Public Service Mutual Provident Association Ordinance (Chapter 283) and confirmed by the Minister of Finance by virtue of the powers vested in him by that Section

#### Rules

The rules published in Gazette No. 5,147 of June 17, 1892, as amended from time to time, are hereby further amended as follows:—

#### CHAPTER I—GENERAL RULES

- Rule 1.—Add the following Rules 1 (ii) and 1 (iii) and re-number the existing Rule 1 (ii) as 1(iv):—
  - "1(ii)—Every person over the age of 30 years but under 35 years of age who is a holder of a pensionable appointment in the State Service or in any quasi-State Department shall be eligible for admission as a member of the Association during a period of one year commencing 1st July, 1973 and ending 30th June, 1974, and during any subsequent period or periods as may be decided at a General Meeting of the Association".
  - "1(iii)—Every person of the age of 30 years or under who is a holder of a permanent but non-pensionable appointment in the State Service or in any quasi-State Department shall be eligible for admission as a member of the Association and such membership shall be subject to special conditions in regard to salary loans under Rule 13, and in regard to the repayment of dues to the Association on cessation of service by retirement or otherwise".
- Rule 4.—Add after the word "member" in line 1 of proviso 2 to Rule 4, the following words:—
  - "Other than a member admitted in terms of Rule 1(ii)".
- Rule 6A(i).—Substitute for the words "but if he continues to contribute a sum of six rupees each month under Rule 9A, Rule 10 shall come into operation at his death", in lines 11 to 13 of Rule 6A (i) the following words" but if he continues to contribute under Rule 9A a sum of rupees six each month, Rule 10, item 5 of Rule 13(ii) in the case of a member admitted other than in terms of Rule 1 (iii), and Rule 14 shall become operative."
- Rule 6B.—Substitute for the words "in a permanent and pensionable post" in line 3 of Rule 6B (i) the words "in a permanent capacity."
- Rule 7.—(a) add the words "in a permanent capacity" after the words "to any post" appearing in line 2 of provisio (a) of Rule 7A (i);
- (b) Substitute for the words "or his granted" in line 3 of proviso (b) of Rule 7A (i) the words "or is granted."
- Rule 10.—(a) Substitute the following for the existing Rule 10 (ii) (c):—
  - "(c) exceeded 30 years but did not exceed 35 years, the amount of donation shall be Rs. 4,300 if he joined the Association prior to 1st July, 1973; and Rs. 3,500 if he joined the Association on or after 1st July, 1973, in terms of Rule 1 (iii)."
- (b) Add the words "as modified by Rule 10 (iv)" at the end of Rule 10 (iii).
- (c) Substitute for the words "appropriate donation set out in paragraph (ii) of the rule reduced by the appropriate amount specified in the Table set out hereunder:—
  - In Rule 10 (iv) the words "appropriate amount specified in the Table set out hereunder.—'
- (d) Substitute for the existing Table appearing under Rule 10(iv) the following Table:—

- Rule 13.—(a) Add the following words at the end of existing rule 13(i) "subject to the condition that in the case of a member admitted in terms of Rule 1(iii), the amount of loan or loans to be granted under this Rule shall not, in any event, exceed twenty-five per centum of the contributions lying to his credit in the books of the Association.
- (b) Add the following words at the end of existing Rule 13(ii) viz. after the word "hereunder", "or if he is a member admitted in terms of Rule 1(iii) twenty-five per centum of the contributions lying to his credit in the books of the Association".
  - (c) Substitute the following for the existing item 5 of Rule 13(ii)-

(5) In the case of a donatory member who has completed 55 years of age and who has not obtained a loan under Rule 14

Three months' pension (exclusive of married Allowance) subject to a limit of Rupees one thousand."

New Rule 14.—Add the following new rule—

"14. Donatory Loan—It shall be lawful for the President (or one of the Nominated Members of the Committee of Management deputed by him) at his discretion to grant to any member who has completed 70 years of age or 40 years of membership in the Association, a loan not exceeding Rupees one thousand five hundred (Rs. 1,500) only bearing simple interest at eight per centum per annum against the amount that shall be come payable from the Death Donation Fund at his death in terms of Rule 10, and such loan shall be recoverable with accrued interest thereon from the donation payable in respect of the member from the Death Donation Fund. Donatory loans paid under this Rule in the case of any donatory member who has already been granted a loan under item 5 of Rule 13(ii) shall not at any time exceed the difference between Rupees one thosuand five hundred (Rs. 1,500) and the amount outstanding out of any loan or loans granted under Rule 13(ii) item 5."

Rule 15.—(a) Add the following words "except as provided for in item 5 of Rule 13(ii)" at the end of the second paragraph of Rule 15(i);

- (b) Substitute for the words "in a pensionable post" in line 3 of the third paragraph Rule 15(i) the words "in a permanent capacity."
- Rule 16.—Add the following rule 16(ii) and re-number the existing rule 16 as 16(i)—

"18(ii)—It shall be the special responsibility of every member admitted in terms of Rule 1(iii) to ensure the prompt payment of dues to the Association through the paysheet or otherwise while in service and direct to the Association on cessation of service by retirement or otherwise."
