ALLOCATION OF LAND ON A 3 YEAR LEASE FOR CHENA RE-FORESTATION WITH TEAK AND OTHER FOREST SPECIES BY THE FOREST DEPARTMENT FOR THE YEAR 1974

APPLICATIONS are invited by the Divisional Forest Officers, Ratnapura, Galle, Nuwara-Eliya, Kurunegala, Trincomalee, Batticaloa, Vavuniya and Jaffna for the allocation of land belonging to the Republic of Sri Lanka on a 3 year lease under the Forest Department re-forestation programme.

2. The location and extents to be allocated in each District for the Year 1974 are listed below. Those persons interested in obtaining land under this Scheme should make their applications to the respective Divisional Forest Officers before December 30, 1973.

3. *Object of Scheme.*—The object of releasing land under this Scheme is to re-forest unproductive Dry Zone forest land with Teak and other forest species while giving opportunities primarily to local villagers and also others to produce various food crops.

4. *Time Schedule for various Operations.*—Exploitation to be completed by May, 1974. Clear felling to be completed by July/August, 1974. Burning to be completed by August/September, 1974. Planting to be done with the rains in October, 1974. Areas should not be burnt before the specified date.

5. *Acreage and conditions of Agreement.*—(a) No individual could be allocated more than five (5) acres.

(b) No re-forestation blocks will be given to timber contractors or persons dealing with timber. Any agreement entered into with any person who is subsequently found to be a timber contractor or a timber merchant will be cancelled.

(c) The selected applicant will be required to sign an agreement with the Divisional Forest Officer on payment of a deposit of Rs. 5 per acre. The agreement will be valid for a period of 3 years, in order to ensure that the whole area which should be planted in the first year is properly maintained for two further years. If the lessee successfully carries out his obligation under the agreement the deposit will be refunded.

(d) All species of timber over 3' in girth and Halmilla over 2'6" in girth will if required be taken over by the State Timber Corporation. Payment for such supplies will be made by the State Timber Corporation. Timber not required by the State Timber Corporation will be given to the agreement holders at rates determined by the State Timber Corporation.

(e) Firewood obtainable from these blocks should if required be handed over to the State Timber Corporation for which payment will be made by them. Firewood and poles not accepted by the State Timber Corporation will be given to the agreement holders on the payment of the prescribed royalties.

(f) Agreement holders removing timber, firewood and poles, will in addition to making payments as specified in (d) and (e) above, will have to pay a deposit of Re. 1 per cu.ft. for timber 50 cents per cu. yard for firewood, 10 cents per Class I pole, 05 cents per Class II pole, and 0½ cent per Class III pole. These deposits will be refunded when the Divisional Forest Officer is satisfied that the area has been successfully planted.

(g) In addition to benefits which may be derived from growing food crops, the Forest Department will pay up to Rs. 100 per acre as reward for successful work over the 3-year period.

6. *Growing Food Crops.*—After the planting work as specified in the agreement is completed the agreement holder is free to plant food crops, leaving sufficient space immediately around the Teak and other forest plants. Food crops generally planted or sown are cereals including paddy, yams, vegetables, chillies, pulses and plantains.
