THE LICENSING OF TRADERS ACT, No. 62 OF 1961

REGULATIONS made by the Minister of Foreign and Internal Trade by virtue of the powers vested in him by sections 3 and 4 of the Licensing of Traders Act, No. 62 of 1961.

#### Regulations

- 1. These Regulations may be cited as the Licensing of Traders (No. 2) Regulations, 1974.
- 2. Every person who is in charge of a petrol supply station shall keep in such petrol supply station an imperial gallon measure stamped under the Weights and Measures Ordinance for the purpose of checking the accuracy of his flow meter.
- 3. Any purchaser who desires to purchase petrol by the gallon may request that the petrol he is to purchase is first pumped into the aforesaid stamped imperial gallon measure before it is poured into the petrol tank of his vehicle.
- 4. Where for the purposes of regulation 3, a gallon of petrol as indicated on the dial of the flow meter is pumped into the stamped imperial gallon measure as aforesaid and the level of petrol in such measure is lower than the mark indicating an imperial gallon the person in charge of the petrol supply station shall add sufficient petrol to the said measure so as to bring the level of petrol to the mark indicating one imperial gallon.
  - 5. In these regulations-
    - "flow meter" means a measuring instrument which measures a quantity of liquid whilst delivering it from a storage tank to a receptacle; "petrol" means petroleum motor spirit and includes diesel oil.

#### Regulations

- 1. These Regulations may be cited as the Publication of Price Orders Regulations, 1974.
- 2. The Controller may, in addition to publishing any order in the Gazette under section 4 (4) (b) of the Act, publish an abriged version of such order in one of the daily newspapers published in Sinhala, Tamil and English.
  - 3. In these regulations-
    - "Act" means the Control of Prices Act (Chapter 173);
    - "Controller" has the same meaning as in the Act.
