##### Hours of Inspection

#### OPPOSITION

**NOTICE** is hereby given that any person who has ground of objection to the registration of the following Trade Marks may, within two months from the date of this *Gazette*, lodge Notice of Opposition on form T.M.No. 7 bearing an uncanceled or impressed stamp of Rs. 25. Formal opposition should not be lodged until after reasonable notice has been given by letter to the Applicant for registration as to afford him an opportunity of withdrawing his application before the expenses of preparing the Notice of Opposition are incurred. Failure to give such notices will be taken into account in considering any application by an opponent for an Order of Costs if the opposition is uncontested by the Applicant.

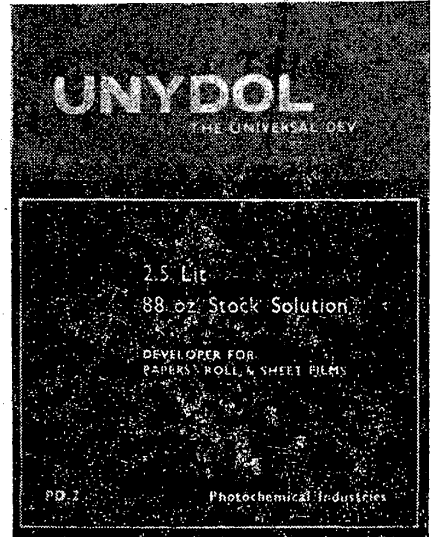

"Method of removing inert ingredients in an ammonia or methanol synthesis system".

*Abstract.*—The nature of the invention can be ascertained from claims 1 and 2 which read as follows:—

1. A method of removing inert ingredients in an ammonia synthesis system characterized in that, in an ammonia synthesis process, a process stream in a synthesis system in which inert ingredients not contributing to the reaction for producing ammonia are contained is washed with liquefied ammonia as a washing liquid in a washing zone provided in said synthesis system, so that the inert ingredients in said process stream may be dissolved into said washing liquid, the thus obtained solution is led to a separating zone provided outside said synthesis system to have here the dissolved inert ingredients

separated and removed, and the regenerated washing liquid having had the inert ingredients separated and removed is returned to said washing zone to be reused.

2. A method of removing inert ingredients in a methanol synthesis system characterized in that, in a methanol synthesis process a process stream in a synthesis system in which inert ingredients not contributing to the reaction for producing methanol are contained is washed with liquefied methanol as a washing liquid in a washing zone provided in said synthesis system, so that the inert ingredients in said process stream may be dissolved into said washing liquid, the thus obtained solution is led to a separating zone provided outside said synthesis system to have here the dissolved inert ingredients separated and removed, and the regenerated washing liquid having had the inert ingredients separated and removed is returned to said washing zone to be reused.
