### PART I: SECTION (I) — GENERAL

#### Government Notifications

THE CEILING ON INCOME AND COMPULSORY SAVINGS LAW, No. 15 OF 1972

BY virtue of powers vested in me by Section 47 (1) of the Ceiling on Income and Compulsory Savings Law No. 15 of 1972, I, Nanayakkarapathirage Martin Perera, Minister of Finance do by this notification declare that the Commissioner-General may grant relief to any person who under that Law is required to make contributions to the Compulsory Savings Fund, if such person proves to the satisfaction of the Commissioner-General that—

- (a) he has, for any year of assessment commencing on or after 1st April, 1974-
  - (i) contributed to any provident or pension fund which has not been approved by the Commissioner-General under the Inland Revenue Act No. 4 of 1963; or
  - (ii) paid any sum as reimbursement to his employer for the value of conveyance provided by the employeer, or
- (b) the profits and income of such person for any year of assessment commencing on or after 1st April 1974 include—
  - (i) the rental value of any place of residence provided rent free by the employer, or
  - (ii) the value of any free conveyance granted by the employer.
