Regulation

Regulation 'D' made by the Monetary Board of the Central Bank of Ceylon and published in *Gazette* No. 10,143 of August 28, 1950, as amended from time to time, is hereby further amended as follows, with effect from April 21, 1975 :

(1) in sub-paragraph (2) (a) of paragraph 1, by the deletion of the words "or partly in rupee deposits in the Central Bank and partly in Ceylon currency notes and coins held by such bank as its assets".

(2) by the deletion of sub-paragraph (2) (b) of paragraph 1.
