It is hereby notified for the purpose of the application of the Order under Section 2 of the Revenue Protection Act, No. 19 of 1962 published in *Gazette Extraordinary* No. 62/9 of 7th June, 1973, that the estimated c. i. f. price of Philippine copra in the London Market for the week commencing on Monday the 14th April, 1975, is Rs. 1,794.00

#### CUSTOMS NOTIFICATION No. 73/2/90

THE following is the estimated f. o. b. value of R. S. S. Grade I rubber, and the rate of export duty for rubber of any description, in terms of the Order under Section 2 of the Revenue Protection Act, No. 19 of 1962, published in *Gazette Extraordinary* No. 69/3 of July 24th, 1973, for the week commencing on Monday the 14th April, 1975.

This duty is in addition to—

- (i) the flat rate of three cents export duty per pound of rubber of any description imposed under section 10 of the Customs Ordinance by Notification published in *Gazette* No. 14,793 of March 16, 1968; and
- (ii) any export duties leviable and payable on rubber of any description under any written law other than the Customs Ordinance.
