3. The office hours are from 8 a.m. to 4.15 pm.

4. Cash transactions will be from 8.30 a.m. to 2.45 p.m.

5. All Notices and Advertisements must be pre-paid. Notices and Advertisements sent direct by post should be accompanied by Money Order, Postal Order or Cheque, made payable to the Government Printer. Postage stamps will not be accepted in payment of Advertisements.
