Notification of Alienation of State Lands by way of sale to persons of the Peasant Class

NOTICE is hereby given that the Government Agent of the Administrative District of Anuradhapura (hereto referred to as the Government Agent) will hold land kachcheries on dates and places to be notified in due course to consider applications from persons of the peasant class for the alienation of state lands described in Schedule "A" hereto by way of sale under the Sale of State Lands (Special Provisions) Law No. 43 of 1973 for the purpose of agricultural development and to select the persons to whom such lands shall be alienated.

2. Applications will be considered only from peasants who are over 18 years of age and who could prove that they were permanent residents on or before 1st June, 1970 in the Thulanas Grama Sevaka Divisions described in the Schedule "B" hereto.

3. Application forms could be obtained from the office of the Divisional Assistant Government Agent of Palaviya and from the offices of the Grama Sevakas described in Schedule "B".

4. Applications may be handed over on dates and places given in Schedule "B" hereto or sent under registered post to reach the Government Agent, Anuradhapura, on or before 24th December 1976. The words "Land Kachcheri Application—Trincomalee Electorate" should be clearly written on the left-hand top corner of the envelope containing the application.

5. Every person desirous of obtaining land should attend the Land Kachcheri in person or depute someone in writing to represent him. If neither the applicant nor the person deputed by him fail to attend the Land Kachcheri, the Government Agent may presume that the applicant does not wish to pursue his application further.

6. Every successful applicant will be entitled to receive approximately half an acre of homestead and two and a half acres of irrigable land.

It has been decided by the Land Commissioner that the purchase price of half an acre of homestead land shall be Rupees One Thousand and Fifteen (Rs. 1,015/-) and an acre of irrigable land shall be Three Thousand One Hundred and Forty Five (Rs. 3,145/); (This includes the undeveloped value of land, cost of development and cost of money and material assistance for development.)

Every person who is selected for land must within two weeks of the date of selection notify the Government Agent whether he prefers to make immediate payment of the purchase amount in full or whether he desires to make payment in instalments. Where a person elects to make immediate payment in full, payment must be made accordingly to the Government Agent within one month of such selection. Where a person elects to make payments in instalments the Government Agent may allow payment in equal annual instalments within such period as he may think fit and such period will not exceed twenty years. Such persons should in addition be required to pay interest at the rate of 4% (four per centum) on the balance of the purchase amount outstanding each year after payment of the annual instalment due for that year.

7. Every successful applicant till, upon the payment in full by the purchase amount as determined by the Land Commissioner for the land for which he has been selected be entitled to receive a grant for that land under Section II of the Sale of State Lands (Special Provisions) Law, No. 43 of 1973.

8. The provisions of the Agricultural Productivity Law, No. 2 of 1972 will apply to all lands sold under this notification. An order of dispossession under the Law may be made in respect of any land that is not satisfactorily developed in accordance of provision under that Law.

9. Every person who receives land is subject to the rules and conditions that will be laid down from time to time by the Mahaweli Development Board in regard to development, water management and payment of service charges.

10. Further particulars may be obtained from the Office of the Assistant Government Agent, Palaviya and the Government Agent, Kachcheri Anuradhapura.
