THE PUBLIC SECURITY ORDINANCE (CHAPTER 40)

Emergency (Regulation of Trade) Regulations

- I, D. Wijesinghe, Competent Authority, under the Emergency (Regulation of Trade) Regulations, do hereby specify-
 - (a) Under Regulation No. 2, the following to be the terms and conditions of the licence to be issued in terms of that regulation, i.e.—
 - (1) The licence shall remain in force until it is suspended or cancelled;
 - (2) The licence does not exempt the licensee from taking any other licence which he may be required to take under any other law, by-law, rule or regulation;
 - (3) The licence is not transferable;
 - (4) The licence shall be exhibited at a conspicuous place in the business premises of the licensee;
 - (5) The licensee shall comply with all the requirements of Emergency (Regulation of Trade) Regulations, and these and any other conditions that may be specified by the Competent Authority by notification in the *Gazette*.
 - (b) Under Regulation No. 3, (i) Rupee One (Re. 1/-) as the fee payable for the issue of a licence in respect of a person who commenced his business within one month of the date of application for such licence and (ii) Rupees Five (Rs. 5/-) in respect of all other persons.
 - (c) Under Regulation No. 16, the articles of merchandise appearing in the schedule hereto essential to the life of the community.
