## PART I: SECTION (I)—GENERAL

### Government Notifications

#### NOTICE UNDER SECTION 29 OF THE LAND REFORM LAW, No. 1 OF 1972

BY virtue of the powers vested in me under section 29 of the Law I hereby direct every person who is interested in any agricultural land or lands described in the Schedule hereto, immediately before the date on which such land or lands have vested in the Land Reform Commission, to make, within one month from 30th December 1976, a written claim in triplicate to the whole or any part of the compensation payable under the Law in respect of such land or lands and to specify in the claim :—

- (a) his name and address ;
- (b) the nature of his interest in such land or lands ;
- (c) the particulars of his claim ; and
- (d) how much of such compensation is claimed by him.

All claims should be addressed to Chairman, Land Reform Commission, and send under registered post.
