146. Postage and Revenue (Commemorative) stamp in the denomination of Rupee 1.00, depicting a picture of Alexander Graham Bell and his invention, the first Telephone.
147. Postage and Revenue (Commemorative) stamp in the denomination of Rupees 5.00 depicting the statue of Goddess Tara.
148. Postage and Revenue (Commemorative) stamp in the denomination of Rupee 1.00 depicting the statue of Sundara Moorthi Swami.
149. Postage and Revenue (Commemorative) stamp in the denomination of 50 cents, depicting the statue of Maitreya Bodhisattva.
150. Postage and Revenue (Special) stamp in the denomination of Rupees 2.00 depicting the Throne of the Kandyan Kings.
151. Postage and Revenue (Special) stamp in the denomination of Rupee 1.00 depicting the Crown worn by the Kings of the Kandyan Kingdom.
