#### THE URBAN COUNCILS ORDINANCE

Order under Section 184

BY virtue of the powers vested in me by section 184 of the Urban Councils Ordinance (Chapter 255), as amended by Act No. 42 of 1968, I, WELIGAMA POLWATTE GALAPPATHTHIGE ARIYADASA, Minister of Local Government, do by this Order, further amend, with effect from 18.11.1976, the Order made under the aforesaid section relating to the Town of Tangalla and published in *Gazette Extraordinary* No. 21/4 of August 23, 1972, as last amended by the Order published in *Gazette Extraordinary* No. 102/3 of March 12, 1974, by the substitution for the last paragraph thereof, of the following paragraph:—

“(b) appoint MR.
