BOARD OF TRADE NOTICES.

THE following notices of the Board of Trade (Fisheries and Harbour Department) are published for general information:—

(F. & H. 15,266.) London, November 14, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram from Her Majesty's Representative at Athens, intimating that ten days' quarantine is imposed on arrivals from Egypt on and after 4th instant.

(F. & H. 15,294.) London, November 14, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Representative at Trieste, enclosing the following Circular respecting quarantine:—

Translation of Circular No. 13,835 of the Imperial and Royal Marine Board to all the Imperial and Royal Offices and Officers and Subordinate Port and Sanitary Offices and Officers—

The Imperial and Royal Ministry of Commerce has decreed by Telegram No. 53,006, dated 4th November, 1900, that henceforward all arrivals from Egypt, as well as those from the ports of the Red Sea, are to be treated, according to Article VIII. of the Venice International Sanitary Convention of 1897, as "non suspect," with the modification that the respective vessels before being allowed free partique shall be subjected to a rigorous medical visit, and that lists of passengers will have to be handed over to the political authorities.

This is made known for information and guidance, with the observation that the regulations issued by Government Circular No. 6,088 of 18th May, 1900, respectively, by Circular No. 6,462 of 7th June, 1899, are by the present Circular annulled.

(F. & H. 15,295.) London, November 14, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Representative at Madrid, intimating that vessels from Grand Bassam, Dakar, Gorea, Rufisque, and Bathurst, Gambia (French Possessions in Africa) will be granted free partique if they arrive in sound hygienic condition without suspicious cases of illness on board, and with a clean bill of health, vised by a Spanish Consul, or by the Consul of some other nation, should there be no Spanish Consul.

(F. & H. 15,348.) London, November 15, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram from Her Majesty's Representative at Brest, intimating that the Sanitary Commission have removed restriction bubonic plague, and that ships from Glasgow for Brest require only bill of health with visa of French Consul at Glasgow, same as Cardiff.

(F. & H. 15,398.) London, November 16, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of the following Telegram from her Majesty's Representative at Constantinople, viz. :—"48 hours' quarantine imposed on arrivals from Alexandria having left subsequent to November."

(F. & H. 15,399.) London, November 16, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram from Her Majesty's Representative at Havre, intimating that ships from Glasgow are now allowed free partique if provided with clean bills of health.

(F. & H. 15,454.) London, November 17, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Representative at Madrid, intimating that arrivals from Alexandria, Beyrout, Trebizond, and Aden will be admitted to free partique if they arrive in sound hygienic condition without suspicious illness on board, and with a clean bill of health vised by the Spanish Consul, or by the Consul of another nation should there be no Spanish Consul at the port.

(F. & H. 15,493.) London, November 19, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs a copy, of a Telegram from Her Majesty's Representative at Rouen, reporting that Glasgow has been declared free from plague.

(F. & H. 15,536.) London, November 19, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of the following Telegram from Her Majesty's Representative at Madrid :—"Glasgow, clean; Cape Colony, foul."

(F. & H. 15,537.) London, November 19, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of the following Telegram, dated 18th instant, from Her Majesty's Representative at Rome :—"Ordinance yesterday revokes quarantine against Australia."
