NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 30th day of June, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

Kirihatana Duraya ; on the south by Galendamukalana (a rock) claimed by the Crown, village boundary of Moradana village, Galeudahena claimed by R. Jotiya ; on the west by Ikkawahena claimed by M. Kirihatana and others and the korale boundary of Beligal korale, a range of rocks, and Tiyambarahena Galabodawatta claimed by Suduhakuruge Pincha.

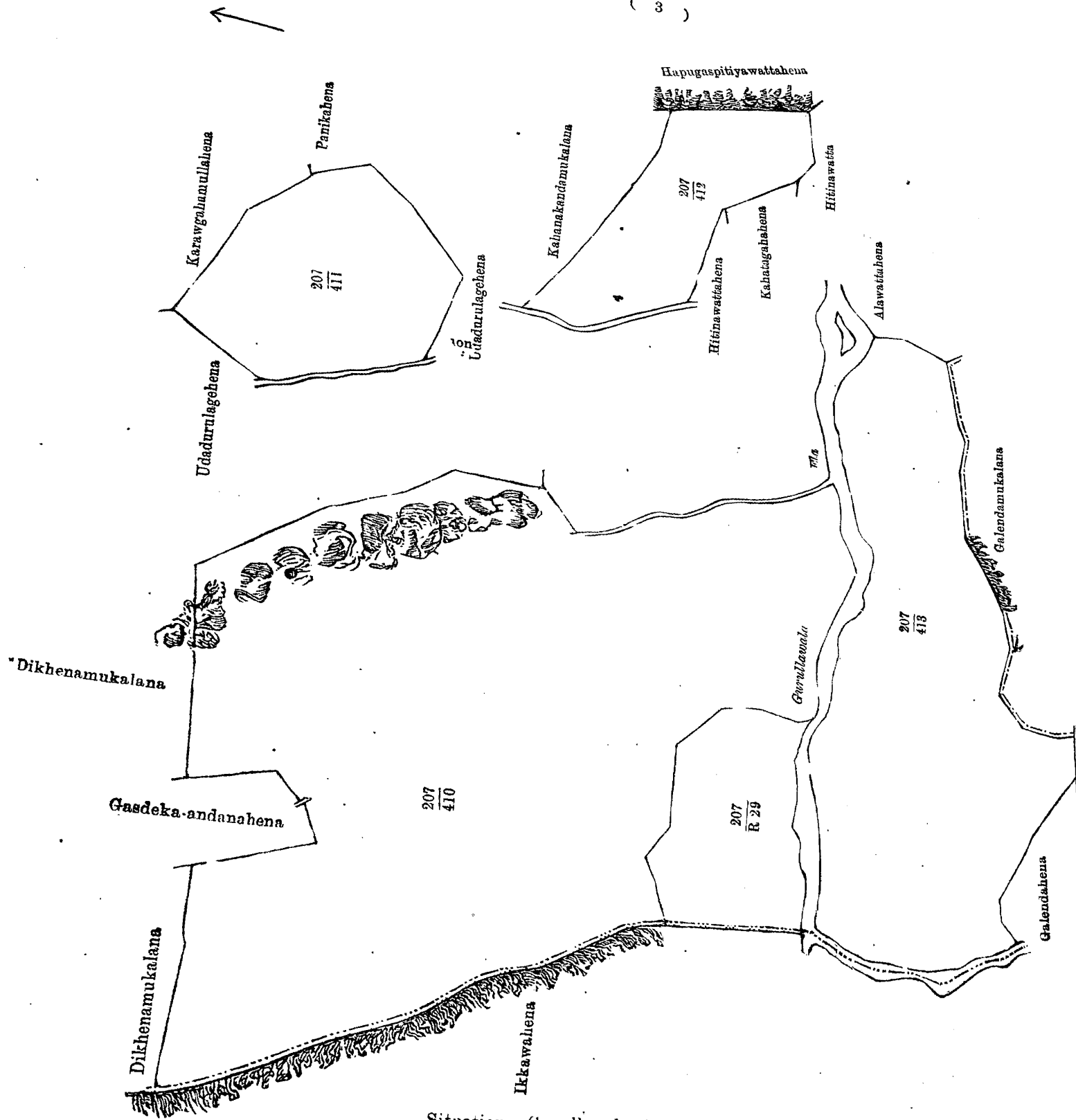

Hapuwa and Dingiriya ; on the west by a stream.

Lot 412 on preliminary plan 207 called Atuwabendawahena, in extent 3 acres and 29 perches ; and bounded on the north by Kahanakandamukalana claimed by the Crown ; on the east by Hapugaspiyawattahena claimed by D. Panchirala and a range of rocks ; on the south by Hitinawatta claimed by W. Mohota, Kahatagahahena claimed by W. Mohota, Hitinawattahena claimed W. Mohota ; on the west by a stream.
