NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897, No. 1 of 1899, and No. 5 of 1900.]

TAKE notice, that unless within three months from the 1st day of August, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned, or in any one of such lands, appear before the Government Agent of the Central Province, at the Kandy Kachoheri, and make claim to the said lands or to either of them or to some interest therein, such Government Agent, in pursuance of the powers vested in him by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands, or such of them as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

On the west by Crown lands called Kolabissa and Kudupolatenna claimed by Udagedera Punchi Etena and Udagedera Muhandirama.


